Multi-Factor Authentication (MFA)

What is MFA?

- Something you know + something you have / something you are



Current Status of MFA



MFA onboarding started 9/12/23.
Activation date still TBD and will be announced soon.



Pilot since December 2022. +150 pilot users: Cabinet, HR, Financial Aid, ITS, Procurement, Accounting, Risk Management, ASO, Academic Senate.



MFA is only needed if you are off campus; everyone logging in off campus will be required to use it.



Reccomended: Microsoft authenticator App



Optional: YubiKey--an external USB device you plug into your computer (request form forthcoming; submit to your supervisor, pending approval)

Why MFA?

Protect Students, Faculty, Staff, and College

- Protects student information: MFA helps ensure that only authorized personnel can access and modify student records, grades, and other sensitive information.
- Protects against identity thefts and other scams. It's the first line of defense against ransomware attacks.
- Need to comply with AP 3723 – Information Security: "ITS shall maintain accountability measures and security mechanisms at all times to control remote access to the District's systems and networks during external remote access use."
- Requested by cyber insurance provider (Keenan).
- Requested by external auditor CliftonLarsonAllen (CLA)
- Aligns with FERPA's authentication requirements for protecting data.
- Our email service provider (Microsoft) has made MFA a requirement since 6/30/22 for Azure clients.

FAQ

Does the MFA phone app require too much access to my personal data, or can my employer monitor my personal activities?

- The mobile application used for MFA (Microsoft Authenticator) doesn't collect any personal data or track/monitor online activities. The ECC ITS Department doesn't have access to the application or the device it is installed on.

Will accessing work-related resources be more complicated or time-consuming?

- MFA is only active OFF campus (when working remote). If you are on campus (wired/Wi-Fi), you won't need to use it. Employees have the option of using their personal phone for MFA validation or an external device.

Will the app impact my phone's data plan?

- If your device is connected to Wi-Fi, no mobile data will be used. If you use the code generated by the Microsoft Authenticator App, no data will be used.

What if I have an older or less common device? Will it support the MFA apps or authentication methods?

- The MFA application selected by the ITS Department (Microsoft Authenticator) is compatible with Android 8.0 and later, iOS 14 or later and Windows 10 Mobile 14393.0 or later. Other options are available for students and employees without a compatible phone.

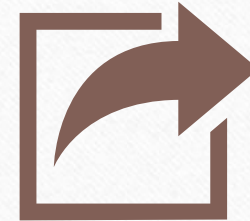
Other Considerations

2024-2025 Academic Calendar Draft

- Calendar committee discussed possibly not starting fall/spring semesters on a Saturday
 - Pro: Avoids confusion for students
 - Implications: Possibly adding a Saturday to the end of the fall/spring semesters
 - Adding December 14, 2024 as an instructional day
 - No change needed to spring 2025; we are starting on a Tuesday and end on a Monday due to holidays
 - Consideration: Commencement will be before last instructional day
- Future calendar discussions:
 - Taking whole week of thanksgiving off
 - Since offices are closed to students during PD day, should we move PD day to slower time in the semester like March/October instead of the beginning of the fall and spring semesters where there is a high need for student support (registration support, etc.)

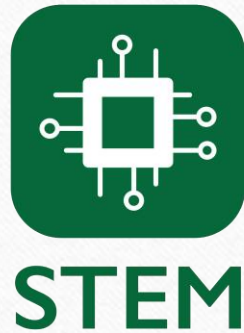
