C. Lopez reported that the initial memo from the state chancellor's office was received regarding implementation of Cal-GETC (AB 928), the new GE pattern that would be adopted in fall 2025. He stated that much work would need to be done by the CCC, which would include updating all existing ADTs to the Cal-GETC curriculum and adopting Cal-GETC as El Camino's GE pattern. In addition, three ADTs are under review due to unit requirements which include Chemistry, Environmental Science and Elementary Teacher Education. L. Suekawa encouraged CCC members to notify their divisions that the three ADTs are on the radar and may be discontinued. It was noted that local degrees can still be offered and a proposal to offer Cal-GETC for STEM is being discussed.
