1. APPROVAL OF MINUTES

2. CHAIR'S REPORT: College Curriculum Committee Chair – E. Ambrosio

Chair Ambrosio thanked the CCC for approving the minutes of September 24 via email, M. McMillan for serving as the Standard Review representative for today's meeting, and J. Minei for agreeing to serve as the Standard Review representative for the next meeting.

Chair Ambrosio reminded the CCC that for new courses, specifically, the consultation fields in Curriculog should be completed after consulting with deans, faculty, counselors, and Library and Learning Resources. The CCC Bylaws were approved at the last Academic Senate meeting. The Bylaws will be updated on the CCC webpage.

4. COMMON COURSE NUMBERING (CCN) UPDATE

VP Lopez advised that funding received for CCN and Cal-GETC will be used for various items, including a project specialist to help with technical and back office work in the Curriculum Office and a part-time faculty member to assist L. Suekawa with Cal-GETC work. Additional funds are reserved for faculty special assignments to complete CCN Phase II and the next 20 courses. Funds will also be used for the Curriculog program update, Colleague projects, faculty professional development, marketing to educate students on Cal-GETC, and supplies, software and equipment. The Chancellor's Office updated the CCN templates slightly for better clarification.

5. Cal-GETC UPDATE

L. Suekawa noted that all courses on the current transfer pattern will be on Cal-GETC for fall 2025. She reminded the CCC that any new courses proposed for Cal-GETC need a two-year timeline for UC approval. Some foreign language courses in the current ADTs may need some adjustments. L. Suekawa offered to provide training on Cal-GETC at a future CCC meeting.

6. LOCAL AA/AS DEGREE UPDATE

L. Suekawa reported that the Degree Taskforce had their first fall meeting. Discussion centered on how to streamline and align with Title 5. Next meeting will be at the end of October to make final decisions.

7. **CURRICULUM SPECIALIST'S REPORT:** Curriculum Specialist – L. Marquez

L. Marquez advised that the updated CCN templates have been uploaded in Teams. A meeting with ITS and Admissions to discuss and test the changes in Colleague is being scheduled.
