1. APPROVAL OF MINUTES

The minutes of September 10, 2024, were approved via email by the CCC on September 17, 2024.

2. CHAIR'S REPORT: College Curriculum Committee Chair – E. Ambrosio

Chair Ambrosio thanked the CCC for approving the minutes of September 10 via email and M. Kline for filling in as pro tem at the last meeting.

Academic Senate tabled the second reading of the CCC Bylaws at their last meeting over concerns regarding the role of administration/deans in the curriculum process. Chair Ambrosio shared onscreen the bylaws, section 1.1, Voting Representatives, and section 5.1, which pertains to the DCC Composition/Responsibilities and Division Dean. VP Lopez responded that it is up to the individual college to decide if they wish to include administrators as voting members. A change to language in section 5.1, in order to clarify curriculum is faculty purview, was suggested as follows:

"The Dean is responsible for coordinating <u>supporting</u> the development of all division curriculum and informing the Council of Academic Deans and Directors of curriculum developments that may affect other divisions."

It was moved by S. Porter, seconded by A. Rodriguez, that the committee approve the change. The motion carried. 12 yes/ 0 no/ 0 abstentions

A discussion ensued on new courses and required fields, such as consultation information, in Curriculog. Chair Ambrosio suggested adding a review of the New Course Proposal Worksheet to the next meeting agenda. VP Lopez suggested adding training workshops to help support faculty locate labor market analysis for reviewing and creating Career Education courses.

4. COMMON COURSE NUMBERING (CCN) UPDATE

Chair Ambrosio clarified the timeline for Phase I of CCN. Phase I courses must be submitted at the state level (COCI) by December 1, approved by the Board in November, and approved by the CCC by the October 22 meeting. Therefore, DCC will need to review the Phase I courses within the next couple of weeks. It was noted that existing programs will be updated at the state level. L. Suekawa reassured the CCC that most course outlines will not need major updates in order to align with the CCN templates. Chair Ambrosio reviewed the proposed 25 Phase II courses which will be broken down into separate timelines. An 11-digit numbering system for the taxonomy will be used to provide consistency across all 116 California community colleges, e.g., ENGL 1A will now be listed as ENGLC1000. Embedded support courses will append the letter "E" and honors courses the letter "H." Chancellor's Office CCN webinars are open to anyone who wishes to attend.

5. Cal-GETC UPDATE

L. Suekawa reiterated that all courses on the IGETC GE pattern will transfer to Cal-GETC, except Oral Communication Studies, which will require some adjustments.

6. LOCAL AA/AS DEGREE UPDATE

L. Suekawa announced that the taskforce is expecting to hold their second meeting on Tuesday, October 1, during College Hour.

7. ANNUAL CERTIFICATION TRAINING FALL 2024

Chair Ambrosio conducted the annual certification training for the College Curriculum Committee. This training is required annually for the college to continue to locally approve specified courses, certificates, and degrees. Elements of local approval certification, local policies and procedures, and the Brown Act were reviewed. The College President, VPAA, Senate President, and CCC Chair will sign the form verifying that the training took place and forward it to the Chancellor's Office.

- 8. CURRICULUM SPECIALIST'S REPORT: Curriculum Specialist L. Marquez
 L. Marquez reported that she added two new folders to the Teams site for CCN and Cal-GETC information. A CCN link was also added to the main CCC webpage. Course outlines were updated in Teams and are currently being updated on the website.
- 9. VICE PRESIDENT'S REPORT: Vice President of Academic Affairs C. Lopez C. Lopez reported that the \$951,000 in funding received to support the Cal-GETC/CCN transition will be used for the Curriculog update for programs, additional staff position to assist with the technical aspects of curriculum, reassign time for individual to assist L. Suekawa, and marketing to students on the new CCN taxonomy.
