C. COLLEGE-LEVEL CRITICAL THINKING ASSIGNMENTS:

- In a 3-5 page typed essay trace the origins of Hindu cosmogony to Vedic and Indo-Aryan traditions and identify examples of artworks that represent aspects of this cosmogony. Include in your discussion the following: fertility deities and symbols, concepts of hierarchy and caste, numerology, the Hindu pantheon of deities, and the concept of macrocosm/microcosm.
- 2. Select one Indian or south-east Asian artwork found in a local museum collection, analyze the artwork's iconography and style and present your conclusions in a typed, 4-5 page essay.
