	This course focuses on pathophysiologic concepts and nursing management essential to critical care and emergency nursing. Patients with acute and chronic cardiopulmonary, hepatic, renal, and multi-system dysfunction will be selected for critical care clinical experiences. Leadership and management skills are introduced and applied in the clinical setting. Students apply the nursing process and prioritize nursing care for a group of patients with multiple needs imbalances. The role of the nurse in the management of patient care following a disaster is presented and students participate in an actual disaster drill in a local hospital.

#### B. TYPICAL ASSIGNMENT USING PRIMARY METHOD OF EVALUATION:

Conduct a Cumulative Index Nursing and Allied Health literature search on a topic related to course content. Select an article of interest from a professional nursing journal and write a critique. Your written critique should describe the content of the article and whether the conclusions support and/or refute current nursing practice.

#### C. COLLEGE-LEVEL CRITICAL THINKING ASSIGNMENTS:

- Write a four-page paper analyzing the significant diagnostic studies on the nursing care of a patient receiving core measures. Cite acceptable diagnostic tests correlating the the diagnosis specific to the core measures as it relates to the patient, with the measures met and nursing interventions in your paper.
- 2. Give a ten- to fifteen-minute oral presentation comparing and contrasting different approaches to conflict management, the resolution of ethical issues, delegation of client care responsibilities, or the assignment of personnel. Teams of at least three students will present their finding to their respective clinical group by videotape, role playing, or panel discussion.
