# Sample Syllabus Statements to Support Student Success



As you prepare for the upcoming semester, the sample statements below can encourage student behaviors associated with success and retention and help proactively address common challenges. Note that these statements, approved by El Camino College's Academic Senate, are only *suggestions*, provided as a service to faculty, and may be modified.

#### Sample Statement RE: Academic Integrity

El Camino College is dedicated to providing a learning environment where you can succeed. In return, we need you to do your part in maintaining academic integrity. To uphold the academic integrity of the institution as a student, you are responsible for behaving in a manner which encourages learning and promotes honesty and to act with fairness toward others.

At El Camino College, academic integrity includes:

- Always turning in your own work written in your own voice
- Always giving credit for ideas/words/images that are not your own
- Never presenting the work of others as your own

In short, as long as you take ownership of your own original quality work, we will do everything we can to support your success. I encourage you to meet with me if you have questions about how to maintain academic integrity in my course.

## Sample Statement RE: Associated Students Organization (ASO)

The Associated Students Organization (ASO) advocates on behalf of the student body and is committed to improving the quality of education and increasing student engagement on campus. They use the funds from the Student Representation Fee and the Student Activities Fee to provide funding to student enrichment programs and support initiatives in the past and present such as the Metro-U pass and Warrior Food Pantry. As the official student representatives and liaisons for the college, their academic division Senators hold office hours. ## Sample Statement RE: Basic Needs Resources

El Camino College is committed to helping all currently enrolled students meet their basic needs to support their academic success. Free food is available through the <u>Warrior Pantry</u>. Students are also encouraged to see if they are eligible for state funded <u>CalFresh</u> Food Benefits. In addition, the <u>Basic</u> <u>Needs Center</u> provides transportation (<u>Metro U-Pass</u>), clothing (<u>Warrior Wardrobe</u>), housing support, referrals for physical/psychological/mental health services and more. # Sample Statement RE: Gender-Based or Sexual Misconduct and Child Abuse or Neglect

**Sexual or Gender-Based Misconduct:** Please know that if you reveal gender-based or sexual misconduct (including sexual harassment, sexual assault, stalking or intimate partner violence) that has taken place on campus or in connection with a school activity to an instructor, counselor, or librarian, we are required by law to report the problem to the Office of Title IX, Diversity & Inclusion. In addition, Registered Nurses, Nurse Practitioners, and Medical Physicians in the Student Health Center are required per California Licensing Requirements to report these types of incidents to local law enforcement.

If you want to discuss gender-based or sexual misconduct confidentially, Clinical Psychologists in the Student Health Center are <u>not</u> required to report such issues to the Office of Title IX, Diversity & Inclusion. ## Sample Statement RE: Land Acknowledgement

Our class convenes on the ancestral land of the Gabrielino-Tongva people, the traditional caretakers of Tovaangar (Los Angeles basin, So. Channel Islands). The El Camino College community benefits from the violent displacement and disenfranchisement of those who lived on this land for generations. We pay our respect to the Gabrielino-Tongva people, past and present, and their connection to this space. We are also aware of the racially discriminatory condemnation of the Gordon Manor tract, a Black residential development project proposed for this land in 1926. We acknowledge a history of involuntary sacrifice that allowed for the establishment and continued existence of El Camino College.

# Sample Statement RE: Linguistic Justice

Challenging linguicism requires acknowledging, welcoming, and celebrating diverse languages and dialects. For many, identity is strongly tied to language, which is why this classroom invites students to bring the entirety of their linguistic capital to the classroom. Linguistic justice in the classroom can look many ways. It may mean listening and reading with grace and patience, avoiding the linguistic correction of others unless provided consent, rethinking how languages are ranked, sorted and stigmatized, integrating and highlighting multilingual writing in our curriculum, creating space for multiple Englishes to be used on assignments, challenging binary language conventions, and reducing the harm caused by ableist language.

# Sample Statement RE: Recording in the Classroom

The use of any recording device during class without the prior consent of the instructor is prohibited, except as necessary to provide reasonable auxiliary aids and academic adjustments to students with disabilities who present official documentation from the Special Resource Center to the instructor prior to recording. This is to protect privacy and to create a safe classroom environment where all participants can discuss potentially controversial or sensitive subjects freely. If you want to take a photograph or make an audio or video recording, you must get the prior written permission of the instructor. The instructor also may require the verbal and/or written permission of everyone present. Even if a student gets permission to record, the recordings are only for personal use and may not be distributed, posted, published, or shared in any manner.

A student who records without instructor permission or distributes any recordings is subject to disciplinary action in accordance with El Camino College District Administrative Procedure 5500 Standards of Student Conduct.

#### Additional Information for Instructors Regarding Recording in the Classroom

This syllabus statement may be adapted to reflect the rules in your classroom. To abide by state regulations, you can determine whether to allow recording; and whether and how non-disabled students must notify you and other students in the class. You must always allow students with a disability to record if they have notified you and shown you their accommodation with the SRC. It is good practice to let students know your policy in your syllabus statement. An important reason to allow recording is that it may help some students better learn your course material. Some reasons to

limit recording are that it may stifle student conversation; it respects student and faculty privacy; it avoids copyright infringement; and it prevents student cheating or avoiding work.

### Ed Code Section 78907

"The use by any person, including a student, of any electronic listening or recording device in any classroom without the prior consent of the instructor is prohibited, except as necessary to provide reasonable auxiliary aids and academic adjustments to disabled students. Any person, other than a student, who willfully violates this section shall be guilty of a misdemeanor. Any student violating this section shall be subject to appropriate disciplinary action. This section shall not be construed as affecting the powers, rights, and liabilities arising from the use of electronic listening or recording devices as provided for by any other provision of law."
