Classroom Discussion Guidelines

- 2. Derogatory statements based on protected class (such as epithets and slurs);
- 3. (Literal) Finger pointing;
- 4. Walking up to/approaching the instructor or other students (ex. getting in one's personal space);
- 5. Yelling, screaming, using profanities;
- 6. Interrupting the instructor or another student while they are talking; talking over one another.

Failure to follow these classroom discussion rules may result in removal from the class, etc.
