**Review Minutes**

**Course Review**

  - i. Inactivation: Math 12, 23, 17A, 27A, 47A – Currently at the Curriculum Office, it is the last step and soon will be inactivated.
  - ii. Math 190 and 191. Currently at the DCC level. Everyone please review and vote in Curriculog.
- b. CS course review
  - i. CSCI-8 & CSCI-9 are at the DCC level. D. Eldanaf reminded everyone to please review and vote in Curriculog.
  - ii. CS 1,12, 14, 40, 99 (two-year) – Computer Science faculty are working on these courses. Once D. Eldanaf receives any updates regarding she will inform everyone via e-mail.

**Updates**

- **Common course numbering** – It was mentioned, that the Chancellor’s office wants all Community Colleges to take their courses and link them to C-ID’s. Many colleges have concerns that this will be a difficult process. The Chancellor’s office has then decided to rather than having all courses linked, to have the popular courses linked to a C-ID as a trial an error. Math 150 is on the list, the respected course number for the C-ID is Math 110. It is unknown if in this project they have to link math 150 to Math 110 or if they want to change the course prefix or units. There is a deadline of one year to get this

completed. Dr. Lemons will get more information for clarification and will inform everyone soon. At the least, Math 150 will need to be linked to a C-ID. ECC will need to be in compliance by Fall 2025. Once concern is if the Chancellor's office says the course prefix has to change, the current Math 110 course will need to be re-numbered.

- **Non-Credit courses in Curriculum** – In Curriculum there are non-credit courses that Matthew Klein had created and launched. These courses are now at the department level and need to be reviewed. Once they are reviewed as a department, they will go to the next process. It was mentioned that the non-credit courses cannot be reviewed at the moment, as S. Acosta-Acuna and O. Villareal are still working on the course objectives, SLO's, and typical assignments to fulfill into the course before it is ready for review. S. Acosta-Acuna will inform D. Eldanaf and Dr. M. Lemons when the non-credit courses are finalized and they will inform the department. Dr. Lemons explained that there will be 2 set of non-credit courses, one set will be offered only in the Fall and Spring semesters, the other set will be offered in the winter and summer sessions. This item will be further discussed at the next math department meeting for clarity and to get faculty input.
- **AB1705 Updates** – Dr. Lemons displayed the High School Metrics for Placement into Transfer-Level Mathematics Courses table, effective Fall 2024. Changes needed to be made because of AB1705, the changes are only for this year until the Math 190S gets approved and how Math 175 will be embedded. One addition, is that students may take Math 165 or Math 190 for Business and STEM majors regardless of their GPA. Another change was adding Math 150 and Math 150S to Liberal Arts, Education, and other majors – corequisite support recommended if the student GPA is <3.00.
- **Revisiting MATH 60 for Dual Enrollment-** There was a discussion if Math 60 should be offered to students at ECC. Main points to consider regarding Math 60:
  - Math 60 is currently still activated.
  - If Math 60 is offered again at ECC, it only can be offered to high school students.
  - If Math 60 is offered, SLO's will need to be completed. Dr. Lemons will bring this topic with DLOACC.

Dr. Lemons asked DCC members if this is something that they are interested in. DCC members agree to bring it back.
