

# **September 21, 2023**

#### **Review meeting**

Greg Fry motioned to approve the minutes from September 7, 2023. All in favor to approve the minutes.

### **Course Review**

Math Courses:

- <u>Math 110-time adjustment (and maybe 116</u>). Last meeting discussion, Dr. Lemons was working with academic affairs on adding 5-10 min to the lab to avoid losing 4 hours over the course of the semester. Update, Dr. Lemons mentioned that the adjustments have been finalized and the courses are now in the schedule for Spring 2024.
- <u>Inactivation: Math 12, 23, 17A, 27A, 47A</u> It was recommended for the Math Academy to inactivate these courses because they are no longer being offered. D. Eldanaf launched an inactivation review, please review and approve to move forward.
- <u>Courses with Math 73/80 prerequisite</u>: It was suggested by CCC to change the wording to "equivalent of intermediate algebra as determined by appropriate placement" because this is accepted by the UC's and CSU's.

CS course:

• <u>Cross listing CSCI-8 & CSCSI-9</u> - In progress, it was suggested for the courses to have math names, Math 108 and Math 109, they will need to be cut and pasted as new courses. Dr. Lemons mentioned that Vice President Carlos suggested to go ahead and do the cross listing and he will meet with Lisette Marquez to see if there is a way for CSCI 8 and CSCI 9 could be put into the system that multiple disciplines can teach the courses.

• <u>DE addendum of CSCI 8 -</u> In progress, once approved it will be offered as Hybrid and Hy-Flex and on-line.

• <u>Math 165 Prerequisite & AB 1705</u> – For non-STEM majors and business, we have to allow students to be able to enter into Math 165 without having to take Math 130, so we cannot require Math 130 prior to taking Math 165, effective July 1<sup>st</sup>, 2024.

This change has to be implemented prior to July 1<sup>st</sup>, 2024. This will be further discussed in the Math Department Meeting.
