- Course renumbering- AB 1111 is asking to match the courses with the CID courses, and has already been matched with the CID and should be in curriculum. It was explained that all that is needed to do is go into curriculum and change the number to a new number.
- COMS 180 cross listing The COMS Department lost the faculty that was teaching this course. Chris Wells reached out and asked if a math faculty can teach this course, Using Statistics for Persuasion. At the moment, there is a concern, if a math faculty should teach this course, and should this course be listed as both COMM and Math. There were no questions, comments or concerns from DCC members regarding COMS 180. G. Valle will take this as an implicit approval and will inform, Dr. Marlow Lemons.
