FACTS AND RECOMMENDATIONS FOR COMPLETING THE APPLICATION:

- EOPS **only** accepts first-generation college students and those whose income falls within the income guidelines above.
- **For priority consideration**, submit the application and two recommendations by December 4th.
- You may not apply for EOP once you are a student on the campus.
- Thoroughly answer the questions as you are provided with an opportunity to explain your academic and financial history.
- One recommendation must come from a counselor, director, or professor. It is strongly recommended for an EOPS counselor if you are a current student.
- Due to the nature of the questions presented to the recommenders, it would be best if you complete your essay questions & provide them your responses. The recommenders have to answer detailed questions about your financial and academic history.

EOP APPLICATION DEADLINES

- All CSU: January 15, 2025 except Fresno and Maritime
- December 2, 2024: Fresno
- June 1, 2025: Maritime

EOP RECOMMENDATION DEADLINES

- All CSU: January 31, 2025 except Fresno and Maritime
- December 16, 2024: Fresno
- July 15, 2025: Maritime
