Background: About the ACCJC Annual Report

In accordance with federal regulations and the Commission [Policy on Monitoring Institutional Performance](#), ACCJC applies a set of annual monitoring and evaluation approaches to assess member institutions' strengths, stability, and ongoing alignment with the Standards during the course of the accreditation review cycle. The Annual Report (AR) is one of the tools used for this process. Using institutions' self-reported data, the ACCJC Annual Report collects headcount information to monitor institutional growth (including growth in distance and correspondence education) and institution-set standards for key indicators of student achievement, licensure exam pass rates, and job placement rates.

El Camino College has continued the process defined for setting Institution Set Standards (ISS) and Stretch Goals (SG) established last year. ISS values are set at the lowest reported value over the previous 5-years. SG values are set on the highest reported over the last 5-years plus five (5) percent. Notably, job placement data comes from Federal Perkins employment data and only the three previous years of data and ISS/SG values are set based on this data.

The College is reporting a significant decline in the number of students who transferred in 2023-2024. We are following up on this data value to validate if it is correct or if there is an error in the data systems intended to capture this data. If the data is found to be an error, then the College will submit an updated ACCJC Annual Report.

Lastly, the College has noted one exam pass rate that is below our institution set standard in the Emergency Medical Technician (EMT) program. This outcome will be evaluated to determine if there is an issue in the program or if it is a single year anomaly. In addition, the College has identified seven career and technical education training programs with job placement rates below their ISS values. The College is following up to determine if these outcomes are related to program issues or a single year anomaly.
