A. ASSOCIATE DEGREE DEFINITIONS AND CRITERIA

It is recommended that the Board approve the definitions and criteria for the Associate in Science degree and the Associate in Arts degree.

Associate in Science:

An Associate in Science degree is granted in a discipline in which scientific thought and investigation are integral within the academic area or where there is emphasis on the application of mathematics, science, or technology.

Adopted by Associate Degree Task Force 3/21/03 Approved by College Curriculum Committee 3/25/03 Approved and adopted by Academic Senate 5/6/03

Associate in Arts:

An Associate in Arts degree is granted in a discipline in which behavioral sciences, fine arts, human movement, humanities, public affairs or social sciences is integral within the academic area.

Adopted by Associate Degree Task Force 3/21/03 and Revised 5/9/03 Approved by College Curriculum Committee 3/25/03 Approved and Adopted by Academic Senate 5/20/03

1. Natural Sciences. Courses in the natural sciences are those which examine the physical universe, its life forms, and its natural phenomena. To satisfy the General Education Requirement in natural sciences, a course shall be designed to help the student develop an appreciation and understanding of the scientific method, and encourage an understanding of the relationships between science and other human activities. This category would include introductory or integrative courses in astronomy, biology, chemistry, general physical science, geology, meteorology, oceanography, physical geography, physical anthropology, physics and other scientific disciplines which emphasize experimental methodology, the testing of hypotheses, and the power of systematic questioning, rather than only the recall of facts. Courses which focus on personal, practical, or applied aspects are not suitable for this category.

2. Social and Behavioral Science

Social and Behavioral Sciences. Courses in the social and behavioral sciences promote an April 18, 2005

appreciation and understanding of how members of diverse societies operate or have operated as individuals and social groups. To satisfy the general education requirement in social and behavioral sciences, a course shall develop an awareness of methods of inquiry and stimulate critical thinking about the ways in which people act and interact within social and cultural contexts.

This category would include introductory of integrative survey courses such as child development, cultural anthropology, cultural geography, economics, family and consumer studies, history, political science, psychology, sociology, and related disciplines.

3. Humanities

Courses in the humanities are those that promote an appreciation of the cultural activities and artistic expressions of human beings. To satisfy the general education requirements in the humanities, a course shall develop the student's awareness of the ways that people throughout the ages have artistically and culturally responded to themselves and the world around them and shall develop the student's aesthetic understanding and ability to make value judgments. This category includes introductory or integrative courses in the arts, foreign languages, literature, philosophy, and religion.

- **4.** Language and Rationality. Courses in language and rationality are those that develop for the student the principles and applications of language toward logical thought, clear and precise expression, and critical evaluation.
 - **A. English Composition.** Courses that fulfill the written composition requirement shall focus primarily on both expository and argumentative writing.
 - **B.** Communication and Analytical Thinking. Courses that fulfill the communication and analytical thinking requirement shall include oral communications, written communications, critical reasoning, mathematics, logic, statistics, and computer languages and programming.

Courses in health and physical education promote lifelong understanding of the basic human need for development and maintenance of good personal health and fitness. To satisfy the general education requirement in Health Education, a course shall help the student develop knowledge of personal health through the examination of health-related social problems, potential preventative strategies, and mediating actions. A Physical Education course shall establish a foundation for regular life-long physical activity and provide opportunities for a student to develop competencies in activities that promote movement, reduce disease risk, and improve overall quality of life.

6. Mathematics Criteria for Associates of Arts/Science Degree

A course designed to satisfy the Mathematics Competency requirement must be at the Elementary Algebra level or higher and shall expand students' mathematical reasoning skills as they develop mathematical arguments. Courses shall integrate numeric, symbolic, functional, and spatial concepts. Courses shall enable students to apply their knowledge of mathematics to meaningful applications and explorations, to solve mathematical problems, and to judge the reasonableness of their results. Courses that are computational in nature are not suitable for this category.

Current Status/Proposed Change

1. Nursing 62 154 – Intermediate Nursing Process, Psychosocial Problems, and Gerontology Mental Health

Units: 5 4 Lecture: 2.5 2 hours Lab: 7.5 6 hours Faculty Load: 54.166 43.333%

Prerequisite: Nursing 60B 150, Nursing 151, and Nursing 61 152 with a minimum grade of C in prerequisite

The student, at In this level, is expected to study, analyze, and use course, students will utilize the nursing process in caring for clients with varying degrees of mental health problems. Psychopharmacological therapies will be examined. Students will apply techniques of therapeutic communication, skills to gather data, to establish and maintain the nurse/client relationship, and to impart information in a systematic and competent manner using the components of the nursing process. The focus of clinical practice is on: defining the role of the nurse in the Mental Health/Psychiatric milieu and community and in the care of the elder using therapeutic communication skills to establish a therapeutic nurse/client relationship; identifying the range of behaviors and the care available for varying types and degrees of administer medications, and assume a leadership role in the clinical setting. In addition, students will utilize and maintain legal and ethical standards specific to mental health problems; and exploring the care of elders with emphasis on gero-psychiatric problems clients.

2. Nursing 63 153 – Intermediate Nursing Process I

Units: 5 4.5 Lecture: 2.5 2 hours Lab: 7.5 hours Faculty Load: 54.166 50.833%

Prerequisite: Nursing 60B 150, Nursing 151, and Nursing 61 152 with a minimum grade of C in prerequisite

Clinical nursing problems that occur due to This course will assist the student in meeting the needs of adult clients with moderately severe disruptions and imbalances of the basic human needs will be studied. Nursing diagnoses which focus on commonly occurring health problems for the adults will be studied. to health. Theory and related utilization of the nursing practice process will focus on pathophysiological problems associated with the pre-operative and post-operative periods, and Students will examine problems associated with the physical integrity, respiratory, activity-rest, ingestive, and excretory, and sexual needs. Collaborative nursing measures to assist clients with chronic O₂CO₂ imbalances will be introduced.

CHANGES IN NUMBER, CONDITIONS OF ENROLLMENT (Pre/Corequisite, Recommended Preparation, or Enrollment Limitation), CATALOG DESCRIPTION; COURSE REVIEW

Current Status/Proposed Change

1. Nursing 66B 156 – Advanced Nursing Pharmacology

Prerequisite: Nursing 60B 150, Nursing 61 151, and Nursing 66A 152 with a minimum grade of C in prerequisite

This course is offers an in-depth study of clinical drug therapy. with emphasis on the knowledge and intervention needed to maximize therapeutic effects and prevent or minimize adverse effects of drugs will be emphasized. Major content areas will include advanced pharmacological

principles; major drug classifications; selected individual drugs; drug effects on body tissues; human responses to drug therapy; and application of the nursing process. Correlation of aAnatomy, physiology, and microbiology concepts are correlated with various pathologies, will be presented with emphasis on health emphasizing the effect(s) of drug therapy on body systems. Health teaching and legal/ and ethical issues are examined.

NEW COURSES

1. Nursing 250 – Intermediate Nursing Process and the Family

Units: 5.5 Lecture: 3 hours Lab: 7.5 hours Faculty Load: 57.5%

Prerequisite: Nursing 153, Nursing 154, Nursing 155, and Nursing 156 with a minimum

grade of C in prerequisite

Credit, degree applicable; Transfer CSU

This course focuses on the theory and clinical application of concepts related to the nursing care of families in the childbearing and childrearing stages. Using the nursing process, students will apply the El Camino College Nursing Program's theoretical framework to meet the basic needs of families as they move through the life stages of pregnancy, birth, and childhood. The importance of structural variables, physical assessment skills specific to maternal-child nursing, and pathological conditions that occur during childbirth, infancy, childhood, and adolescence will be emphasized.

2. Nursing 253 – Intermediate Nursing Process II

Units: 4.5 Lecture: 2 hours Lab: 7.5 hours Faculty Load: 50.833% Prerequisite: Nursing 153, Nursing 154, Nursing 155, and Nursing 156 with a

minimum grade of C in prerequisite

Credit, degree applicable; Transfer CSU

This course will assist the student in meeting the needs of clients with complicated disease states. The synthesis and integration of multiple assessment data in order to utilize the nursing process in caring for medical-surgical clients will be emphasized. Organization and prioritizing care for multiple clients will be stressed in the delivery of total patient care. Increased skill development of nursing procedures and collaborative nursing interventions will be emphasized in the clinical setting. Topics will include pain management, hematology, immunology, infectious diseases, oncology, palliation, and neurological dysfunctions.

1. Communications 1abcd – Student Leadership

Current Status/Proposed Change

Lecture: 1 hour Lab: 2 hours to be arranged

This course Pprovides general training skill building in the areas of time management, goal setting, and listening as they pertain to leadership positions. It also provides education in parliamentary procedure, group dynamics, democratic procedures, and the mechanics of group processes.

Note: This course is required of all current government officers. It also meets the need of potential student government and organization officers and may be elected by any student.

1. Communications 99abc – Independent Study

CHANGE IN CATALOG DESCRIPTION; PROPOSED GENERAL EDUCATION REQUIREMENT; COURSE OUTLINE REVISED TO MEET TITLE 5 REQUIREMENTS

1. English 26 – The Literature of Science Fiction Current Status/Proposed Change

An examination This course examines various types of man's concern for his future through reading, analysis, and class discussion of science fiction literature. Technique and meaning of individual works will be considered in their own right and in relation to other works in the genre. from the 20th century to the present. Students read, analyze, discuss, and evaluate examples of the most widely-read and enduring science fiction genres: space adventure, utopian/dystopian, near-future, high-tech, and futuristic human/social interaction. Students also examine the history of science fiction and the cultural contexts that have given rise to the various science fiction genres. Other science fiction genres may be discussed including gothic, suspense, horror, and fantasy.

None IGETC General Education Requirement – Area 3.

2. Humanities 1 – An Introduction to the Humanities

Current Status/Proposed Change

This course is Aan introduction to the humanities through an historical, descriptive, interpretive, and critical study of film, drama, music, literature, art, architecture, philosophy and history of

the ancient and early medieval world with emphasis on classical Greece and Rome painting, sculpture, and architecture.

Note: Offered This course is only offered through the Consortium for Community College Television operated under the auspices of the Office of the Los Angeles Superintendent of Schools distance education.

3. Journalism 12 – Mass Media and Society

Current Status/Proposed Change

This course is Aa study of mass media and media technologies as they apply to society. Includes a study Students learn the history of the mass media as well as the functions, the responsibilities, as well as a study of media history, development and potential for the future. The course is designed to increase the influence of the mass media on American society. The course increases student awareness of the impact of the mass media in shaping upon society and makes students critical consumers of our mass media.

INDUSTRY AND TECHNOLOGY DIVISION

CHANGE IN CATALOG DESCRIPTION; COURSE OUTLINE REVISED TO MEET TITLE 5 REQUIREMENTS

1. Fire and Emergency Technology 90A – Fire Investigation 1A *Current Status/Proposed Change*

This course parallels the Fire Cause and Origin Determination course offered by the California Fire Service Training and Education System (CFSTES). It provides the student with an introduction and basic overview of fire scene This is the first course in fire investigation. The focus of this course is to provide information and focuses on basic fire scene indicators and to introduce students to concepts of investigation, fire cause, fire scene indicators, fire scene records, and investigative agencies. It applies to Fire Officer and Fire Investigator I certification requirements established by the California State Board of Fire Services.

2. Fire and Emergency Technology 90B – Fire Investigation 1B *Current Status/Proposed Change*

This course parallels the Techniques of Fire Investigation course offered by the California Fire Service Training and Education System (CFSTES). It provides students with information to achieve a deeper understanding is the second course in of fire investigation. This course builds on Fire Investigation 1A and focuses on fire scene documentation, and includes as topics of discussion the juvenile fire setter, report writing, and evidence collection and preservation, searches, interviewing techniques, applicable laws, and courtroom procedures. This course applies to Fire Investigator I certification requirements established by the California State Board of Fire Services.

3. Fire and Emergency Technology 100 – Fire Management 1 *Current Status/Proposed Change*

This course parallels the Management and Supervision for Company Officers course offered by the California Fire Service Training and Education System (CFSTES). It The course is designed to prepare or enhance the first line supervisor's ability to supervise subordinates on in a fire company. It and it introduces key management concepts and practices utilized in the California fire service. This The course includes discussions about decision making, leadership styles, personnel evaluations, and counseling guidelines. This course applies to Fire Officer certification requirements established by the California State Board of Fire Services.

4. Fire and Emergency Technology 110A – Fire Prevention 1A *Current Status/Proposed Change*

This course parallels the first of course in the series of Fire Prevention courses, fire prevention practices courses offered by the California Fire Service Training and Education System (CFSTES). It provides a broad, technical overview of fire prevention codes and ordinances, inspection practices, and key hazards. Some areas of discussion include flammable and combustible liquids and gases, explosives, fireworks, extinguishing systems and others. This course meets National Fire Protection Association 1031, Fire Inspector Professional Qualifications Standards, and applies to Fire Officer, Fire Prevention Officer I, and Public Education Officer certification requirements established by the California State Board of Fire Services.

5. Fire and Emergency Technology 110B – Fire Prevention 1B *Current Status/Proposed Change*

This course parallels the Code Enforcement second course in the series of fire prevention courses offered by the California Fire Service Training and Education System (CFSTES). It is second in the series of Fire Prevention courses that focuses on the codes, and ordinances, and statutes that pertain to fire prevention practices in California. Some The topics of discussion covered include: combustible, flammable, and hazardous materials, building construction and occupancy, evacuation procedures, inspection reports, and processing plans. This course meets National Fire Protection Association 1031, Fire Inspector Professional Qualifications Standards, and applies to Fire Officer, Fire Prevention Officer I, and Public Education Officer Certification requirements established by the California State Board of Fire Services.

6. Fire and Emergency Technology 110C – Fire Prevention 1C Current Status/Proposed Change

This course parallels the Flammable Liquids and Gases course offered by the California Fire Service Training and Education System (CFSTES). It is the third course in the series of Ffire Pprevention courses that and focuses on the storage, handling, and transportation of, as well as the special hazards associated with, flammable and combustible liquids and gases in such areas as bulk storage and handling and transportation of flammable liquids and gases. This course meets National Fire Protection Association 1031, Fire Inspector Professional Qualifications Standards, and applies to Fire Prevention Officer I certification requirements established by the California State Board of Fire Services.

7. Fire and Emergency Technology 111A – Fire Prevention 2A *Current Status/Proposed Change*

This course parallels the Fire Protection Systems and Building Components course offered by the California Fire Service Training and Education System (CFSTES). It is the fourth course in the series of fire prevention courses that provide the participants with the most up-to-date information and focuses on laws and regulations pertaining to fire protection systems, description, installations, and problems relating to fire protection. Topics of discussion includes smoke, heat, and fire detectors, fire alarm equipment, building components, assemblies and devices, fire doors, and basic hydraulic calculations for sprinkler fire extinguishing systems. This course applies to Fire Prevention Officer II certification requirements established by the California State Board of Fire Services.

8. Fire and Emergency Technology 111B – Fire Prevention 2B *Current Status/Proposed Change*

This course parallels the Interpreting the California Administrative Code of Regulations (CCR), Titles 19 and 24 course offered by the California Fire Service Training and Education System (CFSTES). It is the fifth course in the series of fire prevention courses that and provides the participants with extensive, in-depth information about the fire and life safety standards of buildings as they relate to Titles 19 and 24. Topics of discussion include types of construction, construction methods and materials, interior finishes, roof coverings, and occupancy. This course applies to Fire Prevention Officer II certification requirements established by the California State Board of Fire Services.

9. Fire and Emergency Technology 111C – Fire Prevention 2C *Current Status/Proposed Change*

This course parallels the Special Hazard Occupancies course offered by the California Fire Service Training and Education System (CFSTES). It is the sixth course in the series of fire prevention courses that and introduces the participants to some of the more unique or unusual fire prevention challenges. Topics of discussion include: the role of regulatory agencies, high hazard industrial processes, special fire suppression systems, and ovens, cleaning and finishing processes, welding, refrigeration systems, medical gases, and fireworks industrial fire inspections. This course applies to Fire Prevention Officer II certification requirements established by the California State Board of Fire Services.
