This course is a continuation and expansion of the Novell Netware Microsoft Windows System's Administrator course Administration Course. It is designed to help the student build higher level levels of network management skills, and provide the student with the strategies needed for to monitoring and maintaining a Novell Netware Microsoft Windows network. Topics include management strategies, network performance management, advanced printing, remote management, protocol support, installation/configuration, and maintenance. This course is equivalent to the Novell Netware Advanced Administrator's course Microsoft Windows MCSE Infrastructure course.

1. Law 20 – Paralegal Seminar

Units: 3 Lecture: 3 hours Faculty Load: 20.00% Prerequisite: Law 17 with a minimum grade of C or concurrent enrollment

Credit, degree applicable; Transfer CSU

This course focuses on ethics, advanced paralegal communication skills, law office management, problem solving, and analysis skills. It also includes a component on employment, networking and job search. This course is designed to be taken at the end of the paralegal student's course of study.

Included in the course are studies of modern and contemporary ethnic artists examining the cultural roots in such geographic areas as Africa, Japan, China, Mexico, Central and South America, Israel, and the Middle East, as well as the Native American tradition. diffusion, cultural pluralism, and globalization on Western civilization as found in modern and contemporary art and popular culture. Topics include Orientalism, Japonisme, and Primitivism as well as postmodern multiculturalism. Attendance is required at selected performances or speaker events presented by the El Camino College South Bay Center for the Arts and/or art exhibitions presented in the El Camino College Art Gallery.

3. Art 6L – Cross-Cultural Art Performance/Speaker Attendance Laboratory

This course includes attendance at selected Students will attend performances, lectures, or speaker events related to Art 6 offered by the South Bay El Camino College Center for the Arts and/or art exhibitions presented in the El Camino College Art Gallery.

4. Music 62Labcd – Percussion Ensembles Performance Laboratory *Current Status/Proposed Change*

CLASS TITLE: FACULTY COORDINATOR/ARTICULATION OFFICER

BASIC FUNCTION:

The Articulation Officer position is a full-time faculty coordinator position. Under the general direction of the Dean of Counseling and Student Services, the Articulation Officer facilitates the transfer of El Camino College students to transfer institutions, and high school students to the College.

REPRESENTATIVE DUTIES:

- 1. Promote and support intersegmental cooperation to facilitate the transfer of students to CSU and UC campuses, private colleges and universities.
- 2. Responsible for the oversight of the course approval process for CSU breadth courses and the Intersegmental General Education Transfer Curriculum (IGETC).
- 3. Oversee and maintain articulation information on Articulation System Stimulating Interinstitutional Student Transfer (ASSIST).
- 4. Develop, maintain, and publicize California Articulation Numbering (CAN) agreements.
- 5. Direct and maintain the activities of the High School Articulation Project and Regional Occupational Centers.
- 6. Develop and maintain annual curriculum guides for the Associate Degree, certificates and majors of the College.
- 7. Initiate, maintain and disseminate articulation agreements with other postsecondary institutions, especially in the areas of general education/breadth requirements, preparation for the major, course-to-course agreements, and transferable course agreements.
- 8. Ensure the accuracy of published materials relating to articulation matters.
- 9. Develop a system for assuring the timely processing of articulation documents, and monitor each stage of the articulation process.
- 10. Provide training to faculty on how to access and interpret articulation information online or in print.
- 11. Serve on the College Curriculum Committee and, during course review, advise the committee of articulation requirements.

- 12. Advise appropriate administrators, deans, faculty and staff of proposed changes in curriculum that affect articulation and have an impact on students.
- 13. Chair El Camino College Articulation and Advisory Committee.
- 14. Serve on appropriate campus committees, provide input, and receive information about proposed changes affecting or regarding articulation.
- 15. Disseminate policies and information from the articulation unit of the Chancellor's office.
- 16. Participate in conferences and workshops on articulation issues.
- 17. Facilitate campus participation in intersegmental programs (e.g. CIAC, CAN, ASSIST, ICC, ICAS, counselor conferences, and segmental meetings).
- 18. Promote the full inclusion of and effective communication with all students and community users in compliance with Section 508 of the Rehabilitation Act of 1973 by developing and maintaining documents in an accessible format.
- 19. Interpret articulation policies for college departments, receiving institutions and students.
- 20. Advocate for students experiencing difficulties with receiving institutions that may not honor articulated courses.
- 21. Develop an annual articulation plan outlining goals and measurable objectives in consultation with the Dean of Counseling and Student Services, the Vice President of Academic Affairs and the Vice President of Student and Community Advancement.
