<u>Contract – Chevron Energy Solutions and ACCO Engineered Systems</u>

It was moved by Trustee O'Donnell, seconded by Trustee Combs that the Board approve entering into a contract with the joint venture of Chevron Energy Solutions and ACCO Engineered Systems to construct the

Central Plant Project according to the plans and specifications of Request for Proposal #06-005.

Government Code 4217 gives public agencies the ability to procure energy conservation projects though a selection and negotiation process. The Central Plant qualifies as such a project and this procurement process was used.

Proposals were solicited from 17 firms. Four firms responded with proposals. Three firms were interviewed by a panel of District managers and project staff. The fourth firm was not interviewed because the cost of its proposal was significantly higher than the three firms interviewed.

Chevron Energy Solutions and ACCO Engineered Systems was selected based upon the judgment of the selection panel that its proposal represented the best value to the District.

The primary factors considered in making selection included price, the vendor's prior experience with this type of project and the experience and expertise of the proposed project team.

The low proposal was not selected because:

- 1. The firm failed to demonstrate prior experience in similar projects.
- 2. The presentation of a value engineering proposal that would have required DSA approval that would have resulted in a timely and costly delay.

Dates of Service: November 21, 2006 though March 31, 2008.

Cost: Not to Exceed \$12,245,000.

<u>Other Vendors:</u> Honeywell Building Solutions - \$17,250,000, Southland Industries - \$13,998,000, Compass Energy Solutions - \$11,482,000

1. Child Development 135 – Parenting in Contemporary Society

Units: 3 Lecture: 3 hours Faculty Load: 20.000%

Credit, degree applicable; Transfer CSU

In this course, students will examine the principles and practices of effective parenting for children from birth through adolescence. Historical perspectives of parenting styles and

methods will be discussed. Topics will include appropriate techniques for guiding behavior, the influences of school, community, and media in family life, child abuse and prevention, the diverse nature of the family, cultural influences, high risk families, alternative families, and children with special needs. This course is designed for both parents and teachers.

Human Development 8 – Orientation to College <u>and</u> Educational Planning <u>and Guidance</u> This course <u>is designed for first year provides students with the information, skills, and resources necessary for successful educational experiences. Students will become aware of their responsibilities as college students <u>in a diverse college setting</u>. Topics include matriculation, financial aid, cultural diversity, instructional styles, develop an <u>understanding of their individual</u> learning styles, developing positive self-esteem, diagnostic assessment of study skills, decision making, goal setting, create realistic and <u>obtainable</u> educational planning and issues unique to specific populations, such as <u>International Students and Extended Opportunity Programs and Services career goals</u>, develop skills in managing time to achieve goals, and learn how to create a support network using college resources and services.</u>

Human Development 8 – Orientation to College and Educational Planning This course provides students with the information, skills, and resources necessary for successful educational experiences. Students will become aware of their responsibilities as students in a diverse college setting, develop an understanding of their individual learning styles, create realistic and obtainable educational and career goals, develop skills in managing time to achieve goals, and learn how to create a support network using college resources and services.

1. Child Development 160 – Working with Children: Autism Spectrum Disorders

Units: 1 Lecture: 1 hour Faculty Load: 6.667%

Recommended Preparation: Child Development 4 or 32

Credit, degree applicable; Transfer CSU

This course is designed for students interested in working as a paraprofessional with children who have been diagnosed with autism and related disorders. Students will be introduced to the social, emotional, cognitive, and academic needs of these children. The characteristics of effective teaching and the implementation of accommodation strategies in the home and school setting will be explored. The laws governing the rights of children with special needs and their families will be discussed. Students will observe local programs that serve children with autism and related disorders.

2. Child Development 163 – Working with Children: Attention Deficit Disorders

Units: 1 Lecture: 1 hour Faculty Load: 6.667%

Recommended Preparation: Child Development 4 or 32

Credit, degree applicable; Transfer CSU

This course is designed for students interested in working as a paraprofessional with children who have been diagnosed with Attention Deficit Disorder (ADD) or Attention Deficit Hyperactivity Disorder (ADHD). The causes, signs, symptoms, treatment, and implications of these disorders as well as the characteristics of effective teaching methods and the implementation of accommodation strategies in the home and school setting will be explored. The laws governing the rights of children with special needs and their families will be discussed. Students will observe local programs that serve children with ADD or ADHD.

3. Child Development 166 – Working with Children: Physical Disabilities/Health Impairments

Units: 1 Lecture: 1 hour Faculty Load: 6.667% Recommended Preparation: Child Development 4 or 32

Credit, degree applicable; Transfer CSU

This course is designed for students interested in working as paraprofessionals with children with physical disabilities and/or health conditions. Common physical disabilities such as cerebral palsy and spina bifida and other health impairments such as asthma and diabetes will be examined. Students will be introduced to the various types of medical and technological support required for these children during the school day and in the home. Topics will include procedures, equipment, health and safety issues, and the laws governing the rights of children with special needs and their families. Students will observe local programs that serve children with physical impairments or health conditions.

4. History 27 – History of Los Angeles

Units: 3 Lecture: 3 hours Faculty Load: 20.000%

Credit, degree applicable; Transfer CSU

Recommended Preparation: eligibility for English 1A

This course surveys the political, social, and economic history of Los Angeles from its earliest settlement by Native Californians to the present. Topics will include environmental issues, urban development, race and ethnicity, the entertainment industry, and the media's portrayal of Los Angeles. Special emphasis is given to the expanding role of Los Angeles as a global city that serves as a destination for diverse immigrant populations and a center of international commerce.

5. History 37 – History of World Religions

Units: 3 Lecture: 3 hours Faculty Load: 20.000%

Credit, degree applicable; Transfer CSU

Recommended Preparation: eligibility for English 1A

This course is an introduction to the origins, essential doctrines, and historical development of the world's major religious traditions from prehistory to today and their

impact on the societies in which they appear. Major religions examined include Judaism, Hinduism, Buddhism, Christianity, and Islam.

FINE ARTS DIVISION

CHANGES IN CONDITIONS OF ENROLLMENT (Pre/Corequisite, Recommended Preparation, or Enrollment Limitation), CATALOG DESCRIPTION; COURSE REVIEW

1. Art 142abcd – Digital Photography

Current Status/Proposed Change

Prerequisite: one semester of Art 141abcd <u>or Art 151ab</u> with a minimum grade of C or equivalent experience in prerequisite

Recommended Preparation: Art 150 or Photography 51

This is an intermediate level course introduces the computer as a tool for creating, modifying, and manipulating photographic images in the use of digital equipment and software to create original photo-based artwork. Emphasis is placed on improving technique and developing the aesthetic and conceptual possibilities of the image. Topics covered include scanning and digitizing images, output to print and film, color, working with digital cameras, various methods of image input and output, organizing and tracking photo-retouching and photo-montage. Emphasis is placed on art and design concepts files, comparison of file formats, improving and manipulating images, and preparing image files for use in print, web, and multimedia. Digital images are discussed within the broader context of an art historical tradition.

Recommendation:

Prerequisite: one semester of Art 141abcd or Art 151ab with a minimum grade of C in prerequisite

Recommended Preparation: Art 150 or Photography 51

This is an intermediate level course in the use of digital equipment and software to create original photo-based artwork. Emphasis is placed on improving technique and developing the aesthetic and conceptual possibilities of the image. Topics include working with digital cameras, various methods of image input and output, organizing and tracking photo files, comparison of file formats, improving and manipulating images, and preparing image files for use in print, web, and multimedia. Digital images are discussed within the broader context of an art historical tradition.

NEW COURSES

1. Art 108 – History of American Art

Units: 3 Lecture: 3 hours Faculty Load: 20.000%

Credit, degree applicable; Transfer CSU

Recommended Preparation: eligibility for English 1A

This course is an introductory survey of American Art from its pre-colonial past to the contemporary era with a focus on the social, political, economic, and philosophical conditions that have resulted in a culturally diverse artistic tradition. The contributions and influences of immigrants, Native Americans, African Americans, Asian Americans,

Chicano Americans, Latino Americans, and European Americans will be studied in relation to historical contexts.

2. Art 150 – The Art of Photography

Units: 3 Lecture: 3 hours Faculty Load: 20.000%

Recommended Preparation: eligibility for English 1A

Credit, degree applicable; Transfer CSU

This course is a survey of photography as an art form which includes the evolution of photography as art. The course will also cover the aesthetic and cultural impact of photography as art. Also included is an examination of the techniques and methods of traditional and digital photography. Students will learn camera functions and develop their ability to analyze, evaluate, and compose photographs.

3. Art 151ab – The Art of Photography Digital Laboratory

Units: 1 Lab: 3 hours Faculty Load: 15.000%

Prerequisite: Art 150 or Photography 51 or Film/Video 22 with a minimum grade of C in prerequisite or concurrent enrollment

Credit, degree applicable; Transfer CSU

This course introduces the computer as a tool for manipulating photographic images. Topics include digital image input, scanning, and various types of digital output.

Emphasis is placed on the artistic possibilities of the image.

4. Dance 12abcd – World Dance

Units: 1 Lab: 3 hours Faculty Load: 15.000%

Credit, degree applicable; Transfer CSU

This course provides an overview of several specific cultural dance styles which may include African, Afro-Cuban, Mexican, Tap, Middle Eastern, or Asian dance. The study of music, art, costumes, and regional customs of the particular style is also included.

5. Dance 21abcd – Pilates Mat Class

Units: 2 Lecture: 1 hour Lab: 3 hours Faculty Load: 21.667%

Credit, degree applicable; Transfer CSU

This course covers the concepts and exercises developed by Joseph H. Pilates. Emphasis is placed on mat work that features exercises for improving body alignment, strength, flexibility, muscle control, coordination, and breathing. Exercises are designed to enhance dance technique and performance as well as to help the dancer prevent injuries.

6. Dance 26abcd – Hip Hop Dance

Units: 2 Lecture: 1 hour Lab: 3 hours Faculty Load: 21.667%

Credit, degree applicable; Transfer CSU

In this course students are introduced to various forms of Hip Hop dance. The history, vocabulary, social and theatrical codifications, of Hip Hop dance are also explored.

7. Film/Video 4 – Story Development

Units: 3 Lecture: 3 hours Faculty Load: 20.000%

Recommended Preparation: Film/Video 3 Credit, degree applicable; Transfer CSU

This course provides students with a framework for developing dramatic stories for movies and television. Prior to writing a screenplay, students will research and develop an original idea for a screen story. Emphasis will be placed on developing main theme, structure, characters, plot outline, and on writing the treatment.

8. Film/Video 52 – Film, Culture, and Technology

Units: 3 Lecture: 3 hours Faculty Load: 20.000%

Recommended Preparation: Film/Video 1 Credit, degree applicable; Transfer CSU

This course surveys technological innovations in film/video production, distribution, and exhibition and their impact on the entertainment industries and society as a whole. Special emphasis is placed on the economic, social, and political issues raised by technological innovation and the ways new digital and interactive media have both embraced and altered the 'old' media. Screening of films that employ new technology or develop technology related themes are also included.

9. Film/Video 53 – American Independent Cinema

Units: 3 Lecture: 3 hours Faculty Load: 20.000%

Recommended Preparation: Film/Video 1 Credit, degree applicable; Transfer CSU

This course surveys the socio-economic, political, and artistic forces that led to the rise of American Independent Cinema. Emphasis will be placed on studying film makers, such as D.W. Griffith, Roger Corman, Robert Redford, David Lynch, Spike Lee, and Quentin Tarantino, who pioneered producing movies outside of the traditional Hollywood system.

10. Music 555 – Community Choir for the Older Adult

Units: 0 Lab: 3 hours Faculty Load: 15.000%

Non-Credit

This ensemble for the older adult rehearses and performs traditional and contemporary compositions from the standard choral literature. Emphasis is placed on stylistic and historical performance practices, choral techniques, and musicianship. Performances are combined with the College Community Choir and are held on campus and in the community.

11. Music 565 – Community Band for the Older Adult

Units: 0 Lab: 3 hours Faculty Load: 15.000%

Enrollment Limitation: previous band or orchestra experience or ability to perform music of moderate difficulty on a standard band instrument

Non-Credit

This ensemble for the older adult rehearses and performs traditional and contemporary compositions from the standard wind band literature. Emphasis is placed on stylistic and historical performance practices, instrumental techniques, and musicianship. Performances are combined with the College Community Band and are held on campus and in the community.

12. Music 570 – Orchestra for the Older Adult

Units: 0 Lab: 3 hours Faculty Load: 15.000%

Enrollment Limitation: Audition; previous band or orchestra experience or ability to perform music of moderate difficulty on a standard orchestral instrument Non-Credit

This ensemble for the older adult rehearses and performs classics from the standard symphony orchestra literature including works for string and full ensembles. Emphasis is placed on stylistic and historical performance practices, instrumental techniques, and musicianship. Performances are combined with the Symphony Orchestra and are held on campus and in the community.

Emphasis is placed on the principles, techniques, and ethics in the prevention and care of athletic injuries. Study areas include the sports medicine team, legal issues, risk management, pathology of injury, management skills, and specific sports injuries and conditions.

CHANGES IN GRADING METHOD, CATALOG DESCRIPTION; COURSE REVIEW

1. Nursing 214 – Specialized Nursing Skills: Transition to Employment *Current Status/Proposed Change*

Grading Method: Letter grade or Credit/No Credit option

This course will provides the advanced technical skills necessary to increase the nurse's opportunity for first time for increasing employment opportunities in the professional role nursing and for periodic recertification of competency. Emphasis will be placed on advanced resuscitation skills, i.e. in Advanced Cardiac Life Support (ACLS), Pediatric Advanced Life Support (PALS), Neonatal Resuscitation (NRP), and Basic Electrocardiogram iInterpretation. The handling management of chemotherapy agents, as specified by the Oncology Nursing Society, and intravenous insertion will also be covered. Following each content area, the student Students will have the opportunity to take the certification examinations following specific content areas.

Note: This course is repeatable.

Grading Method: Letter grade or Credit/No Credit option

This course provides the advanced technical skills necessary for increasing employment opportunities in nursing and for periodic recertification of competency. Emphasis will be placed on advanced resuscitation skills in Advanced Cardiac Life Support (ACLS), Pediatric Advanced Life Support (PALS), and Basic Electrocardiogram Interpretation. The management of chemotherapy agents, as specified by the Oncology Nursing Society, will also be covered. Students will have the opportunity to take certification examinations following specific content areas.

1. Behavioral & Social Sciences Division

Under the Academic Affairs Area, the Child Development Center (CDC) has obtained the following grants.

San Francisco Community

College District (SFCCD)

9/1/06-6/30/07

This grant is valued at \$12,302.

As part of the California Early Childhood Mentor Program, El Camino Community College District (ECCD) is being funded by San Francisco Community College District (SFCCD) to mentor the Compton Center Child Development Program. Services include coordinating and offering an adult supervision course and seminars for mentors and directors; coordinating and developing mentoring programs; offering honoraria for faculty working with the college mentoring program; providing books and other instructional materials for mentors; and printing and copying mentor materials.

Yosemite Community

College District – Child

Development Training Consortium 8/1/06 – 7/31/07 This grant is valued at \$27,800.

YCCD/CDTC will assist the El Camino College Child Development Department in determining and meeting the needs of individuals seeking new or maintaining currently held child development permits. YCCD/CDTC will pay the El Camino Community College District for student fees and services per the terms of the contract in an amount not to exceed \$27,800 upon receipt of properly completed documentation including an original 2006-2007 Participant Profile for each enrolled student for each semester/term.

2. <u>CalWORKS</u>

The District receives funds through a grant from the State of California CalWORKS Program to assist welfare recipient students obtain the educational level needed to transition off welfare and ultimately achieve long-term self-sufficiency. These funds enable community colleges to be a full partner in the statewide welfare reform system by requiring colleges to provide the following direct student support services: (1) service coordination; (2) curriculum development and redesign; (3) work-study; (4) subsidized child care; and (5) job development and job placement.

Through affiliate agreements, the CalWORKS Office assists in providing support programs for students who are financially and educationally disadvantaged.

3. <u>Industry & Technology Division</u>

The industrial technology program is designed to prepare students to transfer to programs in engineering technology or industrial technology. Industrial technologists are employed in a wide range of careers including managers, management representatives, administrators, production supervisors, trainers, technical support specialists, and technology educators.

Los Angeles Fire Department 5/12/06 –5/13/2009 No Cost

This is an affiliation agreement between the District and the Los Angeles Fire Department to provide access to and maintain staff and equipment for paramedic students to meet educational goals. This includes the assignment of a preceptor, implement schedules, protect health and safety of students and maintain required certificates. The District provides clinical and field internship experience to students enrolled in its Fire and Emergency Technology-Paramedic Technician Training Programs, as part of its credit instructional program, through affiliate agreements.

<u>Compton Fire Department</u> 11/1/06 – until cancelled No Cost This is an affiliation agreement between the District and the City of Compton Fire Department to provide access to and maintain staff and equipment for paramedic students to meet educational goals. This includes the assignment of a preceptor, implement schedules, protect health and safety of students and maintain required certificates. The District provides clinical and field internship experience to students enrolled in its Fire and Emergency Technology-Paramedic Technician Training Programs, as part of its credit instructional program, through affiliate agreements.

Kaiser Foundation Hospitals 7/1/06 - 6/30/07 No Cost

This is an affiliation agreement required by hospitals to support the ECC Paramedic Training Program. The 9th course in a sequence of 10 courses includes 160 hours of training in hospital emergency rooms under the supervision of an ECC faculty member and hospital emergency room personnel. This agreement provides access for qualified paramedic students and for assistance from faculty in the supervision of students in a clinical setting for twenty, 8-hour shifts in an emergency room.

<u>National Science Foundation (NSF) – Advanced Aerospace Manufacturing</u> Education Project

The Board of Trustees, at their June 19, 2006 meeting, approved accepting a grant from the National Science Foundation for this project. The project addresses a need for technical training and education in an industry that is critical to the national interests and will incorporate the best practices from similar projects funded by the NSF and others that have been aimed at other industries. El Camino College, in partnership with Oregon Institute of Technology, Purdue University, and Wichita Area Technical College, will develop and implement curricula. Project participants Boeing, Lockheed Martin, Vought Aircraft and Northrop Grumman will be responsible for implementation of current technology in the manufacturing of aircraft, and the planning for implementation of future technologies. Total amount of Grant Funding from Granting Agency is \$238,607.

MEMORANDUM OF UNDERSTANDING BETWEEN THE EL CAMINO COMMUNITY COLLEGE DISTRICT AND THE

COMPTON COMMUNITY COLLEGE DISTRICT

This Memorandum of Understanding is made and entered into on the day of , 2006, by and between the El Camino Community College District (hereinafter referred to as "El Camino") and the Compton Community College District (hereinafter referred to as "Compton"), acting by and through the Special Trustee appointed by, and acting on behalf of, the Chancellor of the California Community Colleges. In consideration of the mutual commitments contained herein, the parties agree as follows:

- 1. This Memorandum of Understanding, and the parties' implementation of it, is intended to provide a set of binding mutual understandings to achieve the following goals:
 - A. Provide the students and residents of Compton with access to accredited community college programs and services without interruption and in a way that minimizes the disruption students will experience.
 - B. Specify the various rights and responsibilities of each party in providing those programs and services.
 - C. Create the conditions under which Compton will have a genuine opportunity to re-establish its accreditation and regain its independence as an autonomous institution.
 - D. Build effective, mutually respectful relationships between and among the faculty, staff and administrators of El Camino and Compton.
- 2. As authorized by the Chapter 50 of the Statues of 2006 (A.B. 318), El Camino shall establish an educational center to be known as the "El Camino Community College District Compton Community Educational Center," also known as "El Camino College Compton Center" (hereinafter referred to as the "Center") on Compton's facilities in Compton, California. The educational program offered by El Camino at the Center shall consist of a full range of credit and non-credit offerings, and related student support services, as specifically agreed to (and from time to time modified as may be necessary) by the two parties. All programs and services offered at the Center shall be offered exclusively by El Camino. Compton shall not use the term "College" to refer to Compton nor in connection with any activities undertaken by Compton.

- 3. Without implying any limitation on the programs and services to be provided, the parties agree that El Camino will include the following among the programs and services it provides at the Center:
 - A. EOPS, DSPS, CalWorks, GAIN and other categorical programs that are separate from and independent of equivalent programs at El Camino's main campus;
 - B. An Associated Student Body organization at the Center that is separate from and independent of the Associated Student Body organization at El Camino's main campus; and
 - C. Subject to approval by the Commission on Athletics of the Community College League of California, intercollegiate athletic teams that are separate from and independent of the athletic teams at El Camino's main campus.
- 4. If El Camino does not currently offer programs or services that El Camino and Compton, after consulting with the other through the curriculum and program review process, reasonably determines are appropriate and necessary to meet the educational needs of the students and residents of Compton (for example, a larger number of noncredit and developmental courses than now appears in El Camino's curriculum), El Camino shall promptly undertake all reasonable efforts to adopt appropriate curriculum or services. If El Camino reasonably determines that it cannot adopt appropriate curriculum or services requested by Compton, or that doing so would be impractical or ill-advised, El Camino shall work with Compton to attempt to find an alternative means of providing the programs or services. If necessary, such action will require approval from the Accrediting Commission for Community and Junior Colleges (ACCJC) through the substantive change proposal process.
- 5. The educational program and student support services offered at the Center shall be clearly identified as exclusively programs and services of El Camino, and El Camino shall have full authority over all aspects of the programs and services offered at the Center, including but not limited to, curriculum development and approval, program review, student assessment, faculty and staff qualifications and evaluation of performance, student services and institutional planning for the Center. However, El Camino and its Academic Senate shall initiate appropriate measures by which faculty employed by Compton but assigned to provide educational and support services at the Center are appropriately engaged in those activities and accorded appropriate professional standing in academic and professional matters as they relate to the Center.
- 6. El Camino shall have the responsibility to ensure compliance with all federal requirements to ensure that eligible students enrolled at the Center remain eligible for federal financial assistance.

- 7. Compton shall make appropriate District facilities available to El Camino without charge and shall name those facilities the "El Camino College Compton Center."
- 8. The Chief Operating Administrator of the Center shall be a Provost, who shall be responsible to, and supervised by, the Superintendent/President of El Camino in connection with the proper oversight and administration of the educational and student support services at the Center. The Provost shall be appointed with the concurrence of El Camino and Compton and shall serve at the pleasure of El Camino and Compton. While the Provost will report to the Superintendent/President of El Camino, he or she shall be an employee of Compton and Compton shall retain the discretion to assign additional duties to the Provost, including duties as the Chief Executive Officer of the Compton Community College District. In the event the Provost simultaneously serves as Compton's Chief Executive Officer, he or she shall be responsible to, and supervised by, the Special Trustee of the Compton Community College District only for those aspects of his or her assignment that relate to service as Compton's Chief Executive Officer.
- 9. El Camino and Compton shall agree upon a staffing plan for the Center that identifies every position, in addition to the position of Provost, which will be needed to provide educational and support services at the Center and that specifies which of the positions Compton will fund. The parties shall implement the staffing plan as follows:
 - A. To the extent the parties determine necessary and appropriate, Compton shall propose assignment of its current employees to provide services at the Center pursuant to the staffing plan. Before any individual employee is assigned to provide services at the Center, El Camino, in its sole discretion, shall have the right to review the employee's qualifications and to determine if the assignment is an appropriate one. If El Camino determines that the assignment is appropriate, the employee shall remain an employee of Compton and shall not become an employee of El Camino, but he or she will provide services at the Center under the day-to-day supervision of El Camino. If El Camino determines that the assignment is not appropriate and declines to accept the employee, he or she shall not be assigned to provide services for El Camino at the Center.
 - B. If new employees need to be hired by Compton pursuant to the staffing plan, Compton shall promptly undertake reasonable efforts to recruit qualified employees for those positions. Before extending an offer of employment to any individual who will provide services at the Center, Compton shall consult with El Camino to ensure that El Camino has the opportunity to review the prospective employee's qualifications and to determine if his or her assignment to provide services at the Center under El Camino's day-to-day supervision is appropriate pursuant to El Camino's authority under Section 9.A, above, to approve assignments. The process by which El Camino

completes its review and confirms its assent to the selection of a prospective employee shall be specified in the search and selection procedures that Compton and El Camino shall jointly develop. Barring an urgent need to hire new employees, the parties intend to avoid all hiring until they have developed appropriate search and selection procedures. If it is deemed necessary to hire an employee before procedures are developed and adopted, Compton shall use search and selection procedures that are analogous to El Camino's existing procedures and delegate responsibility for conducting the administrative aspects of the recruitment and selection process to El Camino.

- C. Every Compton employee who is assigned to provide services at the Center shall do so pursuant to Education Code Section 74293. No such employee shall be deemed to be an employee of El Camino nor shall any such employee gain any status with El Camino for any purpose.
- 10. El Camino shall have the primary right to direct the activities of employees assigned to provide educational and student support services at the Center consistent with Compton's role as the employer of those individuals. El Camino shall provide employee performance assessments to Compton regarding the services provided by Compton's employees and, if El Camino finds that it is necessary to do so, El Camino may reassign a Compton employee back to Compton after providing Compton with a reasonable opportunity to remedy any circumstances that El Camino believes warrants the reassignment.
- 11. Nothing in this agreement shall be construed to limit El Camino's ability to assign its own employees to oversee activities or to manage the educational and student support services at the Center, or to employ employees of any type or class as otherwise authorized by law as needed to provide oversight of activities or the management of educational and student support services at the Center. Any person who provides services pursuant to this paragraph shall remain an employee of El Camino and shall not be deemed to be an employee of Compton nor shall any such employee gain any status with Compton for any purpose. If they deem it to be appropriate, El Camino and Compton may also enter into inter-jurisdictional agreements with each other to exchange employees needed for an interim period for a specific job classification.
- 12. Compton shall remain responsible for the salary and benefits of its employees assigned to provide educational and student support services at the Center and El Camino shall remain responsible for the salary and benefits of its employees assigned to provide educational and student support services at the Center. Neither party shall have any responsibility for the salary or benefits of the other party's employees.
- 13. As soon as it is achievable following the approval of this agreement, the parties shall organize meetings between appropriate representatives of their respective Academic Senates. The purpose of the meetings is to initiate a dialog between the

parties regarding the academic and professional implications of establishing an educational center that is geographically separate from the El Camino campus and that serves a–student population that has its own particular educational needs and expectations.

- 14. All of the following functions shall remain independent of the Center and shall be managed exclusively by Compton:
 - A. Bond-funded construction and other capital improvement projects associated with the facilities in Compton at which the Center is located.
 - B. Business and other administrative functions that relate exclusively to the management of the Compton Community College District and not the Center.

The parties may agree on other functions or activities that will remain under the supervision and control of Compton; provided, however, that Compton shall not assume any responsibility that requires status as an accredited institution or which, if performed by Compton, would pose a demonstrable risk to El Camino's accreditation.

- 15. As soon after the approval of this Memorandum of Understanding as practicable, the parties shall begin work on devising an explicit methodology by which they will attempt to resolve any disputes that arise between them regarding the interpretation and application of this agreement.
- 16. The term of this Memorandum of Understanding shall be from August 26, 2006, through the end of business on June 30, 2011; provided, however, that it is the intent of the parties to negotiate a comprehensive agreement regarding the continued operation of the El Camino College Compton Center for a period of at least five years. El Camino's decision to enter into such a contract is conditional upon enactment of urgency cleanup legislation compatible with the termination/waiver provisions set out in Paragraph 17 of this MOU, and conditional upon El Camino receiving additional annual state funding of at least \$2,000,000 based upon operating a Center and based upon enrollment in excess of 20,000 FTES. The parties agree to begin negotiations on that comprehensive agreement immediately with the aim of completing the negotiations no later than December 31, 2006 the effective date of the above legislation. Once approved by the Chancellor of the California Community Colleges, acting through the Special Trustee of the Compton Community College District, and the Board of Trustees of the El Camino Community College District, the comprehensive agreement between the parties will supersede this Memorandum of Understanding in its entirety.
- 17. Notwithstanding Paragraph 16 regarding the term of this Memorandum of Understanding, or any other provision of this agreement to the contrary, either party may initiate termination of this Memorandum of Understanding, or any subsequent

agreements between the parties, by giving 90 days written notice to the other party and to the Board of Governors of the California Community Colleges. No termination pursuant to this paragraph may take effect until the end of the semester following the notice provided under this paragraph so as to protect students from a mid-term interruption of educational services. It is expressly understood, however, that in the event El Camino terminates this or any successor agreement between the parties pursuant to this paragraph, the Chancellor of California Community Colleges shall meet with the Superintendent/President of El Camino to determine if the proposed termination by El Camino relates to factors that can be resolved with the Chancellor's assistance. If that is not the case, and if El Camino declines to withdraw its notice of termination within ninety days after it was initially given to Compton and the Board of Governors, the Special Trustee shall immediately exercise the discretion delegated to him or her under Education Code Section 74292(1)(2), regarding termination of the agreement. In that event, the Special Trustee, the Chancellor and the Board of Governors of the California Community Colleges will be deemed to have waived any and all rights whatsoever that they may have to require El Camino to continue to provide services. This waiver provision is irrevocable; and is a material inducement for El Camino's agreement to execute this Memorandum of Understanding.

- 18. El Camino shall provide fiscal and administrative oversight for the operation of the Center and all matters related to the Center. The budget for the Center shall be jointly developed and approved by El Camino and Compton. Compton shall provide fiscal and administrative oversight of any activities of Compton which are separate from, and unrelated to, the Center; e.g., Compton's bond program.
- 19. Within thirty days of the execution of this Memorandum of Understanding, Compton shall remit to El Camino the sum of \$500,000 towards the full compensation that El Camino shall be entitled to receive for administrative overhead it will incur preparing for and implementing this Memorandum of Understanding. Other reimbursable expenditures, not to exceed \$1,000,000 annually, shall be paid promptly by Compton upon submission by El Camino of appropriate invoices.
- 20. Compton shall save, defend, hold harmless, and indemnify El Camino in connection with any and all claims, actions or lawsuits that arise in any manner from the acts or omissions of Compton, its officers, employees or agents in the performance of this agreement or that arise in any manner from the acts or omissions of El Camino, its officers, employees or agents in the performance of this agreement. It is expressly understood that in the event of a claim, action, or lawsuit based upon an act or omission of a Compton employee assigned to provide services at the Center under this agreement, the Compton employee shall not be deemed to be an agent of El Camino unless the act or omission giving rise to the claim, action or lawsuit was one required by El Camino or taken at the explicit direction of an El Camino supervisor or manager.

<u>Community College Governance, Funding Stabilization, and Student Fee</u> <u>Reduction Act</u>

Trustee Mary E. Combs requests that the El Camino Community College District Board of Trustees consider adopting a resolution in support of the "Community College Governance, Funding Stabilization, and Student Fee Reduction Act."

Resolution in Support of the Community College Governance, Funding Stabilization, and Student Fee Reduction Act

WHEREAS, California Community Colleges serve 2.4 million students annually through a system of 72 locally-established and governed community college districts with 109 colleges within a statewide system;

WHEREAS, California Community Colleges need stable funding, predictable student fees, local control, and the ability to provide effective leadership for the system of 109 colleges;

WHEREAS, the California Community College Initiative (officially known as the Community College Governance, Funding Stabilization, and Student Fee Reduction Act) would ratify the bilaterally-governed community college system by placing it in the State Constitution, thereby securing local governance while enhancing state leadership;

WHEREAS, the use of the actual community college enrollment growth figure would avoid the artificial funding cap that would otherwise be imposed on community colleges over the next ten years because of declining K-12 enrollment;

WHEREAS, the California Community College Initiative will provide additional funds to the El Camino Community College District over the next five years;

WHEREAS, the California Community College Initiative would not threaten funding for K-12 education in California because primary and secondary education would retain a separate funding mechanism tied to its growth;

WHEREAS, the California Community College Initiative funds the increase to community colleges over the next ten years through natural growth in the state's general fund, without raising taxes;

WHEREAS, the California Community College Initiative reduces student fees to \$15 to make them stable and predictable as well as consistent with personal income, and

prohibits the Legislature from increasing fees in the future by more than the change in per capita personal income;

WHEREAS, the California Community College Initiative ensures that fee revenue stays with the community colleges for the improvement of education, instead of being diverted to other state programs;

WHEREAS, the California Community College Initiative would allow the Board of Governors and Chancellor to hire the senior staff professionals currently appointed by the governor, and thus have the same authority as that provided to the UC President and CSU Chancellor;

WHEREAS, the California Community College Initiative includes provisions in the state constitution for locally-elected governing boards accountable to voters and for a statewide chancellor hired by a board appointed by the governor;

NOW, THEREFORE, be it resolved, that the Board of Trustees of the El Camino Community College District supports the Community College Governance, Funding Stability, and Student Fee Reduction Act.
