This course provides instruction in risk factor identification and modification for cardiovascular related diseases including the metabolic syndrome. Emphasis is placed on healthy lifestyle behaviors including exercise training, proper nutrition, and weight management. B. <u>CONTRACT – SOUTHLAND INDUSTRIES - ENERGY MANAGEMENT</u> <u>SYSTEM EXPANSION</u>
