Students will gain greater awareness of their learning preferences and how to apply them to increase their reading and learning levels. Students will construct a learning system which will facilitate their ability to read, to understand, and to critically evaluate reading material.

1. Electronics and Computer Hardware Technology 62 – Introduction to the Electric Power Industry

Units: 2 Lecture: 1.5 hours Lab: 1.5 hours Faculty Load: 17.5% Credit, degree applicable; Transfer CSU

In this course, students are introduced to electric power generation and transmission. Topics will emphasize employment opportunities in the powerline industry. The course will include a general overview of the types of power systems, electricity generation, basic electrical theory, history of power generation and distribution, power system protection, system reliability, and power industry governance.

 Electronics and Computer Hardware Technology 64 –Electric Power Industry Safety Units: 2 Lecture: 2 hours Faculty Load: 13.333%

Credit, degree applicable; Transfer CSU

This course addresses OSHA (Occupational Safety and Health Administration) regulations for the electric power generation and distribution industry. The topics covered include OSHA regulations for the utility industry, personal protective equipment, fall protection, hazardous material handling, fire protection, hand and power tools, and electrical distribution safety components. Students successfully completing the course will be eligible to take the examination for the OSHA (30 hr) safety-training certificate.

3. Electronics and Computer Hardware Technology 68 –Electric Power Transmission and Distribution Systems

Units: 3 Lecture: 3 hours Faculty Load: 20%

Credit, degree applicable; Transfer CSU

This course provides an in-depth study of the electrical components used in the transmission of electricity from generation to the user. Students will study switchyards and substations as well as learn the operation of transformers, circuit breakers, regulators, capacitor banks, tap changers, disconnects, current and potential transformers, and

lightning arrestors. The various types of electrical conductors, structures, and insulators used in the transmission of electricity will also be studied.

1. Mathematics 41A – Elementary Algebra, Part I

Current Status/Proposed Change

Note: Students enrolled in this course are required to participate in group activities.

## B. <u>TENTATIVE BUDGET 2007–2008</u>

It is recommended that the Tentative Budgets, including the General Fund-Unrestricted, General Fund-Restricted, Student Financial Aid, Child Development, Capital Outlay, General Obligation Bond, Workers' Compensation, Property and Liability Self-Insurance, Dental Self-Insurance, Special Reserve Fund-Retiree Health Premiums, and Bookstore Funds for the 2007–2008 fiscal year be submitted to the Board for first review and then adoption at the June 18, 2007, meeting. California Code Regulations Section 58305(a) requires that, on or before the first day of July, each community college district shall file a tentative budget with the County Superintendent of Schools.

# D. <u>CONTRACTS \$69,000 OR HIGHER</u>

It is requested that the Board of Trustees approve that the District enter into the following agreements:

1. <u>STUDENT AND COMMUNITY ADVANCEMENT DIVISION</u>

The Student and Community Advancement Division provides contract training to private industry consistent with the California State Education Department's emphasis on economic development.

**a.** <u>Contract Education Department</u> delivers learning programs, tools and other performance support services that contribute to continuous workforce development. Contract Education works with businesses to develop customized curriculum to meet strategic business needs and offer the training on a flexible schedule to accommodate employees' work schedules. Contract Education also supports regional and statewide marketing activities to increase employer awareness of the economic development services available from community colleges. These programs are funded directly by the contractor and are not state funded.

Long Beach Community <u>College District (LBCCD)</u> 1/1/07-12/31/07 Grant: \$250,000 In-Kind Match

Through a grant/cooperative agreement with LBCCD, the Small Business Development Center (SBDC) will serve as a "Network Service Center" and will provide and deliver services to small businesses.

**b.** <u>Workforce Development Department (WDD</u>) - offers a diverse number of educational and professional services to the business community, non-profit organizations, students, and alumni by building partnerships. Our goal is to connect employment and training opportunities to the community. The majority of WDD services are free to employers and students, however some training courses are fee-based.

The Community College Foundation (TCCF) contracts with the County of Los Angeles Health Services – Department of Children and Family Services (DPHS-DCFS) to provide necessary education and skills training for various state-funded programs. El Camino College (ECC) receives funds via a subcontract with TCCF to assist in providing training for individuals enrolled in designated state-funded programs.

The Foster and Kinship Education Program provides both foster (resource) parents and relative caregivers with on-going classes that develop their

skills and increase their knowledge so that they enhance their ability to provide safe and nurturing environments for the children.

1. <u>The Community College</u> 1/1/07-6/30/07 Income NTE: \$72,450 <u>Foundation (TCCF)</u>

ECC will provide up to nine training workshops, at \$8,050 each, for students and family members enrolled in the state-funded program Kinship Education, Preparation and Support Program (KEPS) as caregivers.

2. <u>The Community College</u> 2/1/07-1/31/08 Income NTE: \$72,900 <u>Foundation</u>

ECC will be providing up to nine training workshops at \$8,100 each, for individuals enrolled in the state-funded program Partnering for Safety and Permanence – Model Approach to Partnership in Parenting (PS-MAPP) program.

E. <u>BID #2006-14/COMPUTER EQUIPMENT, SOFTWARE & PERIPHERALS</u> It is recommended that the Board approve entering into a contractual relationship with Dell Marketing for the purchase of computer equipment and peripheral equipment manufactured by Dell to Dell Marketing L.P.

The authority for this purchase is made possible through the cooperative purchasing Agreement (number A63307) between Dell Marketing L.P. ("Contractor") and the Department of Administration ("State") on behalf of the State of Minnesota, participating members of the National Association of State Procurement Officials (NASPO), members of the Western States Contracting Alliance (WSCA) and other authorized participating States and participating entities. Note: Assembly Bill 1684 (1999-2000) enabled the State of California and the Department of General Services to enter into cooperative purchasing agreements with other states. The term of this agreement is September 1, 2004, through August 31, 2007 (3 years). The Agreement may be mutually renewed for two (2) additional one-year terms unless terminated pursuant to the terms of this Agreement.

# F. <u>BID #2007-1/LEASED DIGITAL COPIERS</u>

It is recommended that the Board approve entering into a sixty (60) month contractual relationship with Ricoh Business Systems for the lease of approximately forty-one (41) digital copiers to replace the currently leased Minolta copiers whose contract with the District is due to expire June 30, 2007.

The District has chosen to utilize a "piggyback" provision of Sections 81640 to 81654 of the Education Code and Sections 20651 to 20659 of the Public Contract Code. "The governing board of any community college district, without advertising for bids if the Board has determined it to be in the best interest of the

district, may authorize contract, lease, requisition, or purchase order...to lease...supplies, equipment...for the district in the manner in which the public corporation or agency is authorized by law to make the leases or purchases." This provision is used by the district to take advantage of lower costs realized through economy-of-scale and also to avoid the time and expense of the public bidding process. Although not required under these provisions, the District considered and evaluated several companies who expressed an interest in the copier lease program. It was ultimately determined that Ricoh Business Systems provided the most advantageous program for the District's needs. Due to the large volume of use by the District, consideration and evaluation included customer support (past and present), monthly lease pricing for efficient page-per-minute service, excess usage charges, and the benefits of dealing directly with manufacturer versus distributors.

The authority for this lease is made possible through the "piggyback" provision of Bid No. BW7123-3/07-OTR, titled purchase and lease of multi-function copy machines of the Miami Dade County in cooperation with U.S. Communities Government Purchasing Alliance. The term of this contract shall be from July 1, 2007 through June 30, 2012. Note: Assembly Bill 1684 (1999-2000) enabled the State of California and the Department of General Services to enter into cooperative purchasing agreements with other states.

Annual estimated lease cost is \$71,128.20 and does not include excess copy charges, optional accessories or applicable sales tax. Labor, delivery, removal is included.

## B. MODULAR BUILDING PURCHASE

It is recommended that the Board of Trustees approve the purchase of a food service modular building at a cost not to exceed \$192,000 from Modular Structures, Inc. Delivery and installation is included.

The authority for this purchase is made possible through the piggybacking provision of Nuview Union School District's Bid # 2005-Modulars.

## C. <u>CONTRACT AMENDMENT - CW DRIVER HUMANITIES BUILDING</u> <u>REPLACEMENT PROJECT</u>

It is recommended that the Board of Trustees approve increasing the fee amount for the construction management services contract with CW Driver by \$223,702.

<u>Background</u> - On February 22, 2005, the Board of Trustees approved a contract with CW Driver, in the amount of \$1,600,000, for construction management services to be performed on the Humanities Building Replacement Project. The term of the contract is 18 months. The construction management services to be provided occur in four phases: pre-bid, bidding, construction and post construction.

It was anticipated the Division of the State Architect (DSA) would approve the project plans in December 2005 and the District directed CW Driver to begin performing its services in December 2005. Unfortunately, DSA did not approve the plans until February 2006.

In April 2006, the District delayed awarding construction bids to May 2006 due to a bid protest and bidder notification.

The District's contract with CW Driver provides for a fee increase if a material change occurs in the project schedule through no fault of CW Driver. The District and CW Driver have negotiated a fee increase of \$233,702 for the increased term of the contract.

The total project budget is unchanged. The increase will be paid from the project contingency.

#### D. <u>CONTRACT AMENDMENT - CW DRIVER LEARNING RESOURCES CENTER</u> <u>ADDITION PROJECT</u>

It is recommended that the Board of Trustees approve increasing the fee amount for the construction management services contract with CW Driver by \$111,851.

<u>Background</u> - On June 19, 2006, the Board of Trustees approved entering into a contract in the amount of \$550,000 with CW Driver to perform construction management services for the Learning Resources Center Addition.

The reduced fee (\$500,000) was negotiated on the basis that CW Driver would concurrently be performing construction management services on the Bookstore/Cafeteria Conversion. However, now the construction periods will not overlap. The Bookstore/Cafeteria Conversion Project has been delayed due to the need to revise the design to incorporate a larger dining area.

The total project budget is unchanged. The increase will be paid from the project contingency.

#### E. <u>CHANGE ORDER – LEARNING RESOURCES CENTER ADDITION</u>

It is recommended that the contracts for the prime trade contractors listed below be adjusted by the amounts indicated due to design changes in the work.

#### **Contractor**

ML Moe, Inc.

#### <u>Amount</u> \$18,766

Reason – Additional work to install an added 50 feet of sewer line. This is necessary due to an unforeseen condition. The existing campus sewer line was not in the location shown on the drawings. It was necessary to extend the new sewer line to the actual location of the existing sewer line.

<u>Contractor</u>	Amount
Southern Counties Quality Masonry	\$15,810

Reason – Additional material and labor to install a smaller size brick than that specified. This change is due to a request by the District. The smaller brick will more closely match the brick on the existing Library Building.

The total project budget is unchanged. The increase will be paid from the project contingency.

## F. <u>CHANGE ORDER – CENTRAL PLANT</u>

It is recommended that the contract for ACCO Engineered Systems, Inc. be adjusted by the amounts indicated due to changes in the work.

Delete the high voltage conduit, cabling and gas meter installation. (\$130,369) This work was added to the scope of the infrastructure project being performed by another contractor. The change was made to expedite the project schedule.

Replace and reroute high voltage conduit and cabling within the 92,450 work site. During excavation it was discovered that a portion of this line interfered with the buildings foundation and was badly deteriorated.

Increase size of gas line to the boilers from 6" to 8". The increase in 117,927 size is due to the possibility the natural gas supplier may not provide an increase in line pressure. Install additional pressure differential sensors to modulate the speed of water pumps. This change will improve the pumping system's efficiency. Add a refrigerant detection and shut off system and connect to the emergency generator. This change will provide for increased operational safety and reliability.

## Total Change Order Amount\$80,008

The total project budget is unchanged. The increase will be paid from the project contingency.

# G. <u>CHANGE ORDER – INFRASTRUCTURE PHASE 1</u>

It is recommended that the contract for Mel Smith Electric, Inc. be adjusted by the amounts indicated due to changes in the work.

Add high voltage conduit and cabling installation adjacent to the \$127,283 Central Plant project. The cost of this change is offset by a credit from the contractor performing the Central Plant work. The change was made to expedite the Central Plant's schedule.

Add a 12" valve to the fire water distribution system. This change 6,634 was made to improve the ability to maintain and operate the system.

Increase the size of the project's electrical vaults. This change is 84,445 necessary due to an electrical code requirement. A portion of this cost may be recoverable from the project's design firm.

Additional excavation necessary due to unforeseen underground 12,002 conditions which increased the depth and complexity of the excavation.

Install slurry concrete backfill instead of native soil backfill in the <u>17,026</u> street area adjacent to Construction Technology Building due to native soil condition being unsuitable for backfill.

# Total Change Order Amount <u>\$247,390</u>

The total project budget is unchanged. The increase will be paid from the project contingency.
