Background: the district apportionment for academic year 2004 - 2005 was 19,306 FTES. The following year an enrollment decline yielded 18,202 FTES. However, since the State allows a district to decline in enrollment for one year without penalty, the district was stabilized at the previous year's apportionment of 19,306 FTES. Stabilization is granted to a district for one year, thereafter, the district will earn what it actually produces.

If a district does not recover from an enrollment decline in the second or succeeding years, it may shift FTES from the upcoming year summer session. Shifting FTES is another option for a district to stabilize during enrollment declines which may sometimes last two to three years.

This table demonstrates the effect of the shift in 2006 - 2007 and 2007 - 2008.
