A. BOARD POLICIES – (SECOND READING AND ADOPTION)

It is recommended that the Board accept the following Board policies for second reading and adoption:

Board Policy 4100.1

Catalog Rights

Catalog Rights are a specific set of requirements The El Camino College Catalog specifies the general education, major, and unit requirements which the student must satisfy to qualify for an Associate Degree, a Certificate of Competence, or a Certificate of Completion. Students who have maintained continuous attendance enrollment may choose to graduate under the catalog requirements in effect either 1) at the time they began attending El Camino College continuously or 2) at the time they graduate from El Camino College. For degree and certificate purposes, continuous attendance enrollment is defined as enrollmenting at El Camino College at least one semester, (excluding summer and winter terms) each ealendar academic year; and receiving courses must be noted on the transcript with a letter grade, a 'W," or CR/NC designation on the transcript.

El Camino College Policy Adopted: 9/20/93 Renumbered: 4/18/05

Amended:

Students may repeat a course in which they have received a substandard grade (that is, D, F, or NC) only once. The new grade and credit will be substituted for the prior grade and credit in computing the grade point average (GPA) and the permanent academic record will be annotated in such a manner that all work remains legible, insuring a true and complete academic history.

In general, students are not permitted to repeat courses in which they have earned a grade of A, B, C, or CR.

Students who have received a W in a course are permitted to re-enroll in that course two more times, for a total of three enrollments.

Specific exceptions to the above policies are detailed in administrative procedures.

This policy supersedes the section of BP 4220 (Standards of Scholarship) dealing with Course Repetition.

Procedures for implementing the policy will be developed with collegial consultation with the Academic Senate, as defined in CCR § 53200.


Excerpt from Board Policy 4220 (Standards of Scholarship) regarding Repeating Courses:

1. Repetition of a Course in Which D, F, or NC Was Received

- A. Students who receive grades of D, F, or NC in an El Camino College course may reenroll in that same course one more time. Students will not be permitted to enroll in that course for a third time except under unusual circumstances and upon written permission of the division dean. Unusual circumstances are verified cases of accidents, illnesses or other circumstances beyond the control of the student.
- B. The student, upon successfully repeating a course in which a grade of D, F, or NC had been previously received, may notify the Records Office in writing. Upon receipt of such written notice, the student's transcript will be amended so that the previous grade and credit will be disregarded in the computation of the grade point average. The permanent academic record shall be annotated in such a manner that all grades assigned remain legible, ensuring a true and complete academic history.

Students who have received a substandard grade (that is, D, F, or NC) will be allowed to repeat that course only once. Students will not be permitted to enroll for a third time except under unusual circumstances and upon written permission of the division dean. Unusual circumstances are verified cases of accidents, illnesses, or other circumstances beyond the control of the student.

Upon completion of the repeated course, the previous grade and credit will be disregarded and the new grade and credit will be substituted in computing the grade point average (GPA).

Students who have received a substandard grade who then successfully complete an equivalent course at another accredited institution may petition the Records Office to have the previous grade and credit disregarded in computing their GPA and to have their academic record annotated.

If the course is one with lowercase letters such as Chinese 11ab or Journalism 11abcd and students repeat a course to alleviate a substandard grade, they can petition the Records Office to have the previous grade and credit disregarded in computing their GPA and to have their academic record annotated.

Nothing in the policy and procedure on Course Repetition can conflict with Education Code §76224 pertaining to the finality of grades assigned by instructors or with Title 5 or district procedures relating to the retention and destruction of records.

Students who have received a grade of A, B, C, or CR in a course may repeat the course only under the circumstances listed below:

- 1. A student may repeat a course if, upon written petition to the dean of the relevant division, the district determines that the student's previous grade is, at least in part, the result of extenuating circumstances. Extenuating circumstances are verified cases of accidents, illnesses, or other circumstances beyond the control of the student. The new grade and credit will not be counted towards the student's total units or GPA.
- 2. A student may repeat a course if, upon written petition to the dean of the relevant division, the district determines that repetition is appropriate to the student's goals because of a significant lapse of time. The new grade and credit will not be counted towards the student's total units or GPA.
- 3. A student may repeat any number of times courses which are necessary to meet a legally mandated training requirement as a condition of continued paid or volunteer employment. The district maintains a list of courses to which this procedure applies. The resulting grades and credits will be counted towards the student's GPA.

4. A student may repeat courses with lower case letters (for example, Chinese 21ab or Journalism 11abcd) up to the number of letters (that is, Chinese 21ab may be taken a total of two times and Journalism 11abcd a total of four times.) No special permission is required, and all credits and grades earned will be included in the student's GPA.

A grade of W does not count as a repetition for the purposes of this policy. However, college policy allows a student to re-enroll in a specific course in which the student has received a W only two more times, for a total of three attempts. Any exception to this policy requires the student to meet with a counselor to review academic goals and strategies for success.

The limitations detailed in this procedure do not apply to special courses designed for students with disabilities. Such courses are defined as being taught by an instructor with minimum qualifications established by Title 5, § 53414, such as a master's degree in rehabilitation counseling. However, when such students take regular classes, they are subject to the same repetition limitations as other students.

Additionally, procedures have been developed to ensure that students are not permitted to enroll in courses for which they are not eligible and to ensure that the college's apportionment claims are in compliance with the California Code of Regulations and Title 5 § 58161 in this regard.

Board Policy 4240

Academic Renewal

It is the policy of El Camino College to allow previously recorded substandard academic work to be disregarded if it is not reflective of a student's more recently demonstrated ability and if repetition is not appropriate to the current objectives of the student. A student may petition to have up to 24 semester units of substandard work (D, F or WF grade assigned) taken at El Camino College disregarded in determining the student's grade point average.

Procedures for implementing the policy will be developed with collegial consultation with the Academic Senate, as defined in CCR Title 5, Section 53200. This policy supersedes the section of BP 4220 (Standards of Scholarship) dealing with Academic Renewal.

Reference: Title 5, Section 55765

Excerpt from Board Policy 4220 (Standards of Scholarship) regarding Academic Renewal:

Students may petition to have up to 15 units of D, F or WF grades from not more than three consecutive semesters of previously recorded substandard course work at El Camino College disregarded in computation of grade point average under the following conditions:

- A. The student has demonstrated academic ability by earning a grade point of 2.25 or higher in the last 30 units of graded course work at El Camino College.
- B. At least two years have elapsed since the substandard semester.

The Academic Renewal Committee will act upon only one petition to disregard substandard semesters per student. Course work disregarded may not be used to meet degree requirements. The permanent academic record shall be annotated in such a manner that all grades assigned remain legible, ensuring a true and complete academic history.

Academic Procedure 4240

Academic Renewal

A student may petition to have up to 24 semester units of substandard work (D, F or WF grade assigned) taken at El Camino College disregarded in the determination of the grade point average

(GPA), subject to limitations as follows:

1. The student must have earned a GPA of 2.25 or higher in the last 30 units of graded work, or 2.5 or higher in the last 24 units of graded work, completed at any regionally

accredited college or university.

2. At least two years must have passed since the end of a semester with a grade to be

disregarded.

3. A student may be granted academic renewal at El Camino College only once.

4. Units disregarded by other institutions shall be deducted from the 24 semester units

maximum of course work to be disregarded by El Camino College.

5. Course work with disregarded grades may not be used to meet degree or certificate

requirements.

Academic renewal actions are irreversible.

Students requesting Academic Renewal may obtain an Academic Renewal Petition in the

Records Office.

The student's permanent academic record shall be annotated to indicate all disregarded course

work, but all grades shall remain legible to ensure a true and complete academic history.

If another accredited college has removed previous course work from associate in arts or bachelor's degrees consideration according to terms of that institution's policy, such an action

shall be honored by El Camino College.

It is the student's responsibility to ensure that any institution or program to which he or she is

applying will accept Academic Renewal from El Camino College.

These procedures supersede the provisions of BP 4220 dealing with Academic Renewal.

Reference: Title 5, Section 55765

It is the policy of El Camino College to provide enhanced educational opportunities for students wishing to explore a subject area more fully by establishing an Independent Study program. Under the guidance of a supervising instructor qualified to teach in the specific subject area, students in Independent Study courses will complete projects that reflect scholarly or creative efforts of an advanced nature that go beyond the scope of a regular course.

Independent study projects must be approved by the supervising instructor and will require the student to meet regularly with the instructor. Academic standards applicable to Independent Study courses will be the same as those applied to other credit courses.

To be eligible for Independent Study, a student must be in good academic standing and

- 1. Have completed at least 12 degree-applicable units at El Camino College with a GPA of 3.0 or higher, and
- Have demonstrated competence in the discipline in which the Independent Study course is being attempted by completing at least two courses in this discipline with a grade of B or higher, and
- 3. Be concurrently enrolled in at least one other course at El Camino College

Procedures for implementing this policy will be developed by the Superintendent/ President in collegial consultation with the Academic Senate.

El Camino College Policy Adopted:

- 1. The supervising instructor will scrutinize proposed projects for appropriate depth and rigor. Such projects might, for example, include a lengthy research study, an original production, or a comprehensive exam. The supervising instructor will provide appropriate orientation, guidance, and information regarding course content materials and services and will document progress toward project completion. Projects will be evaluated by the supervising instructor, and the basis for evaluation will be kept on file for at least one semester.
- 2. Independent Study projects will normally be for one unit of credit, with a maximum of three units per semester; one unit of credit will be granted for 60 hours of work devoted toward the project. A student may earn a maximum of six units of Independent Study at El Camino College.
- 3. To promote an individualized educational experience for each student, an instructor will supervise a limited number of Independent Study students in one semester or session, as determined by the terms of the Agreement between the District and the ECC Federation of Teachers in effect at that time. In accordance with the Agreement, the Dean of the division in which the Independent Study will be offered shall approve or disapprove each course to be offered.
- 4. Academic standards applicable to Independent Study courses will be the same as those applied to other credit courses. Independent Study courses will be accepted by the college toward completion of an associate degree and shall be eligible for transfer credit by an institution of the University of California or California State University.

Board Policy 4030 Academic Freedom

The El Camino Community College District recognizes that institutions of higher education are conducted for the common good and not to further the interest of either the individual faculty member or the institution as a whole. The common good depends upon the free search for truth and its free exposition. Academic freedom is essential to these purposes and applies to both teaching and research. Academic freedom is fundamental for the protection of the rights of the faculty member in teaching and of the student in learning. It carries with it responsibilities correlative with rights.

Accordingly, a faculty member shall have the freedom:

- 1. To examine or endorse unpopular or controversial ideas either in classroom teaching or in discussions with students as is appropriate to the course content, or in academic research or publication, while recognizing the responsibility to be accurate, objective and respectful of others. Faculty also have the responsibility to grade students solely on the basis of evidence of knowledge of the material pertinent to the class and attainment of appropriate skills, or other generally accepted grading criteria, avoiding any bias generated by a student's political outlook, religious belief or other personal attributes.
- 2. To select or recommend the selection of course instructional materials that may contain unpopular or controversial ideas, with the correlative responsibility that these materials are pertinent for the course.
- 3. To speak or write as a citizen, provided that the faculty member recognizes the special professional obligations of an educator to be accurate, objective and respectful of others, and that the faculty member take care to avoid leaving the impression that he or she is speaking for the college or the district.
- 4. To select or recommend library books, materials, media and online resources representing a multiplicity of philosophies and points of view, relying on professional expertise to maintain appropriate depth and breadth of the collections.

A faculty member shall not be subject to any adverse action affecting his or her employment with the El Camino Community College District for exercising any of the foregoing choices.

Board Policy 4030 supersedes Board Policy 4030.1 (Teaching of Controversial Issues).

Freedom of discussion is vital in the complex problem of controversial issues. Instructors and students should strive to develop methods for dealing with controversial issues in a fair and productive manner. In discussing issues, the effective instructor is objective and circumspect, observes the customary rules of good taste and courtesy, is loyal to America's traditions and ideals, and is aware of the age and maturity of his students in relation to the subject. Academic freedom depends upon the instructor's ethics, skill, knowledge, and good judgment.

Instructors and administrators must recognize that existing state and local regulations pertaining to controversial issues are legally binding and useful. These regulations refer to communists, religious fanatics, racists, political organizers, advocates, pamphlet distributors, and others who may cause injury or embarrassment by their presentation of issues on the campus and in other college-sponsored activities.

An excerpt summary of pertinent sections from the California Education and Government Codes and the policies of the El Camino Junior College District follows:

Loyalty Oath, Communism, and Communist Affiliations

The loyalty oath was created by statute in 1953 (California Government Code, sections 1368 and 3108). The California Education Code provides for dismissal of known communists from teaching positions (sections 12957 and 12958) and states that no teacher shall advocate or teach communism "with the intent to indoctrinate any pupil or inculcate a preference in the mind of any pupil for communism" (8455). Should there be any question regarding communism or communist affiliations, it is the duty of any employee of the school district to appear and specifically answer under oath the questions of any committee, or subcommittee of the Congress of the United States or the Legislature of the State of California (12955). Employees must also appear before the boards of trustees to answer questions under oath. Failure to appear or answer, no matter what the reason, may result in dismissal (12956). If in appearing before these investigating committees or boards of trustees, an employee gives "an indirect or evasive answer" or an answer "which neither affirms or denies," that employee shall be considered to have failed or refused to answer "regardless of the ground or explanation" given (12951). This failure or refusal can result in dismissal (12956).

Race, Color, and Creed

Teachers are not permitted to instruct nor may entertainment be presented in a way to reflect upon citizens of the Unites States because of their race, color, or creed (8451) and no textbook, chart or other means of instruction which so reflects may be used (8452).

Morals, Manners, and Citizenship

The Education Code also obligates teachers to impress upon the minds of their students, the "principles of morality, truth, justice, and patriotism" and to instruct students in the

"principles of a free government" and the "rights, duties, and dignity of American citizenship" (7851).

Sectarian, Partisan, or Denominational Publications or Teachings

"No publication of a sectarian, partisan, or denominational character, shall be distributed or used for sectarian, partisan, or denominational purposes in any school, except that nothing herein shall restrict the development and use of school library collections. No sectarian or denominational doctrine shall be taught in any school. Any school district or city, the officers of which knowingly allow any classes or students to be taught in violation of this section, forfeits all rights to any state or county apportionment of school moneys, and upon satisfactory evidence of any violation, the Superintendent of Public Instruction and school superintendent shall withhold both state and county apportionments (8453)."

Propaganda and Solicitation of Funds

"(a) No bulletin, circular, or other publication of any character whose purpose is to spread propaganda or to foster membership in or subscriptions to the funds of any organization not directly under the control of the school authorities, or to be used as the basis of study or recitation or to supplement the regular school studies shall be distributed or shown to the pupils of any public school, on the school premises during school hours or within one hour before the time of opening or within one hour after the time of closing of the school.

"(b) No pupils of the public schools shall be solicited by teachers or others to subscribe to the funds of, or work for, any organization not directly under the control of the school authorities.

"(c) No instruction shall be given through lectures or other means, unless the material contained in the bulletin, circular, or publication, or the purpose of the subscription or instruction has been approved by the State Board of Education, or by the county board of education, or by the governing board of the school district in which the school is situated. "No prohibition of this section shall apply to bulletins or circulars concerning the meetings of their organizations issued by any parent teacher association or by any organization of parents formed for the purpose of co-operating with the school authorities in improving school conditions in the district.

"Any student political organization which is affiliated with the official youth division of any political party that is on the ballot of the State of California may hold meetings on a junior college campus and may distribute bulletins and circulars concerning its meetings, provided that there is no endorsement of such organization by the school authorities and no interference with the regular educational program of the school (8454)."

Immoral or Unprofessional Conduct, Disobedience as Grounds for Revocation or Suspension by State Board

"The State Board of Education shall revoke or suspend for immoral or unprofessional conduct, or for persistent defiance of, and refusal to obey, the laws regulating the duties of persons serving in the Public School System, or for any cause which would have warranted the denial of an application for a certification document or the renewal thereof, or for evident unfitness for service, life diplomas, documents, or credentials issued pursuant to this code (13202)."

Related El Camino College Policies (4136, 4137 and 5136) El Camino College Board of Trustees policy states that:

"2. Except as permitted under the Civic Center Act, the following activities upon property under the jurisdiction of the El Camino Junior College District Board of Trustees are specifically prohibited

"a. Posting of political circulars or petitions on bulletin boards.

"b. The distribution, to employees, whether by placing in their school mailboxes, or otherwise, of political circulars or petitions, United States mail being excepted.

"c. The collection of and/or solicitation for campaign

funds.

"d. Solicitation for campaign workers.

"e. The use of pupils for writing or addressing political materials, or the distribution of such materials to pupils."

(4136)

Discussion of political issues in the classroom should be appropriate to the subject under study.

"5. Violation of any of the foregoing rules shall, at the discretion of the El Camino Junior College Board of Trustees, constitute cause for reprimand, demotion, suspension, discharge, or dismissal". (4136)

A. APPROVAL TO DEPOSIT FUNDS WITH SOUTHERN CALIFORNIA COMMUNITY COLLEGE DISTRICTS' SELF-FUNDED INSURANCE AGENCY FOR WORKERS' COMPENSATION PROTECTION

It is recommended that the Board approve payments not to exceed \$1,000,000 to Southern California Community College Districts' Self-Funded Insurance Agency for Workers' Compensation Protection for the payment of workers' compensation claims during the 2006-07 budget year. A payment of \$500,000 is to be made in July 2006; the balance is to be made by October 2006. This total amount is provided in the Workers' Compensation Fund for the 2006-07 budget year.

The Protected Insurance Program for Schools (PIPS) Joint Powers Authority has notified the District of a reduction of the District's Workers' Compensation rates for the '06 – '07 fiscal year. Our total premium is \$948,514; a reduction of \$123,717 from last year. This has occurred for a number of reasons, including, but not limited to, current insurance markets, reduction in workers' compensation medical costs resulting from the governor's workers' compensation reforms, and ECCCD's continuing excellent experience modification rates, loss control efforts, and low frequency and severity of claims.

B. CHANCELLOR'S OFFICE TAX OFFSET PROGRAM

It is recommended that the Board approve the participation of the District in the Chancellor's Office Tax Offset Program (COTOP). By contracting with the Chancellor's Office, a request is made to the Franchise Tax Board to offset (deduct) the amount of unpaid fees a student owes the District from the student/debtor's personal state income tax refund, lottery winnings or other state refund. The Franchise Tax Board remits any amounts offset to the Chancellor's Office. Authorization is then given to the State Controller to disburse the offset amount, minus a 25% administrative fee, to the participating local districts. From 1996 through 2003, the COTOP program returned almost \$5 million to participating districts.

C. <u>TEMPORARY CASH BORROWING</u>

It is recommended that the Board of Trustees approve temporary borrowing of cash between District funds to meet cash flow shortages July 1, 2006 - June 30, 2007. The interfund borrowing is primarily done when a fund is awaiting reimbursement or appropriation and there is a payment obligation. This primarily occurs with the Student Financial Aid fund.

It is recommended that approval be given to make adjustment to the 2005-06 General Fund Unrestricted revenues and expenditures as outlined below.

C. <u>CONTRACT - RMA GROUP - HUMANITIES BUILDING</u>

It is recommended the Board of Trustee's approve entering into a contract with RMA Group to provide special testing and inspection services for the Humanities Building Project.

Project: Recording Board of Trustees monthly meetings for distribution to public access TV/cable stations for broadcasting.

Preliminary research into the practicality and cost of recording voice and/or video of the Board of Trustees monthly meeting outlines four initial options for the Board to consider. Currently, the College has a relationship with Torrance Cable through Time Warner. Expanding to the other eight cities in the South Bay service area will require establishing contracts with several other cable companies. The availability of public access channels in these cities is unknown.

Some information was gathered through contacts with a consultant specializing in designing and overseeing installations of audio and video recording systems. To be accurate, a more complete assessment must be contracted at a cost of \$5,000 to \$7,000 that would include design of an appropriate system.

As this is new territory for staff in the media center, knowledge is limited and they have not had enough time to complete a comprehensive overall analysis of the proposed project.

Four options are presented for the Board of Trustee's consideration.

Option 1: Audio Recording. Audio recordings of the Board of Trustees meetings will be loaded on a server for anyone interested in listening to the live meeting recordings. Access to the meeting recordings is made through the college website. A new server is required to support this web based service. Each member of the dais and podium will have a microphone that is live (on/off switches) during the entire meeting.

Option 2: Video recording using one technician and camera. In this option meetings will be recorded by a single technician and one camera. At the end of each meeting the videos are sent to participating public access TV/cable stations.

Estimated cost of labor and equipment:

Note: A connection wall jack would have to be installed to get video signal back to video recorder that would be located in the equipment cabinet. End product (video) would not be very good and the operator and equipment (camera & tripod) would take up space in board room.

Option 3: Video recording using 3 remotely operated cameras. Three cameras will be permanently installed in the Board Room and controlled remotely by a technician during the meetings. Each seat at the dais and podium will be equipped with a microphone. Videos will be sent to participating public access TV/cable stations.

Option 4: Live video recording linked to a public access TV/cable station. This option will use the equipment in Option 3; however, a direct uplink to a TV/cable station is required. Depending on scheduling, the Board of Trustees meetings will be live real time transmissions. Live transmission of video from the College to the City of Torrance or Time Warner cable will require coordination and cooperation with Time Warner engineering staff and new contracts with other cable and city governments in the service area. The cost of the latter is unknown.

Future consideration or an Option 5:

There is yet another option for the Board to consider, but the College is not ready to deploy and operate live video streaming housed on the College website. To have live video streaming on the College website, the Board must purchase the equipment and installation for Option 3 plus a server for about \$50,000.

The video systems proposed in all of the options are bare bones systems without production support. Features like subtitles, closed or open captioning, live captioning, Board Member titles and names, and other speaker titles and names will not be included in the videos or live transmissions. The systems are designed for the Board Room only, moving to other areas of the campus will require additional portable equipment purchased by the Board.

Option 5 is an important consideration, but the College is about two years from having the capacity to install this on the College website. It is anticipated that this technology will replace video technology in the very near future.
