Reconvene in Open Session; Announce Closed Session Actions The Regular Meeting reconvened to Open Session at 5:10 p.m.

1. It was moved by Trustee Brown, seconded by Trustee Vargas, that the Board approve the Stipulation for Final Judgment in favor of the District, signed by the Petitioner in regards to Case BS 165113. The stipulation substitutes a stipulated final judgment in favor of the District instead of a dismissal to end the litigation.

3. It was moved by Trustee Vargas, seconded by Trustee Combs, that the Board ratify a Resolution Agreement proposed by the Office of Civil Rights in regards to Case 09-17-2067.

To resolve an accessibility complaint, the Resolution Agreement requires the District to:

- Work with the complainant and prepare a plan to provide the most effective access to the College's stadium and gyms;
- Upon completion of College construction, assess accessible paths of travel and signage and remove any accessibility barriers found; and
- Develop accessibility notification procedures and policies.

Trustees Beverly, Brown, Combs, and Vargas voted yes. Motion carried.
