The Board of Trustees approved a settlement agreement between the District and the City of Torrance for payment of charges due from the District to the City of Torrance for water services between 2011 and 2017, which were not billed by the City of Torrance to the District as water

services were being provided. The settlement agreement reflects a reduction of more than 50% or \$250,000 from what would have been paid by the District if the City of Torrance had billed for water services on an on-going basis. District staff is authorized to execute the settlement agreement with the City of Torrance and to implement the terms of the settlement agreement.
