It has been approved for funding in the Governor's Budget for January. We will have to wait until June to see if is in the final budget. We have already done 98% of the planning and are waiting for appropriation of the monies to spend it.
- h. We are gearing up to update our Facilities Master Plan process.
- i. We are doing a space utilization student for the future needs to the campus.

- Looking at the South side of the campus, PE South and PE are all is gone replaced with grass. We are looking at the cash flow and this may not be possible in the future. Once the Pool and Classroom bldg. is open, we will be closing the old pool, so we can remove it form the space inventory.
- Marsee Auditorium This map is from the 2017 Facilities Master Plan look out into the future. We have assessed the Marsee to see if it can be refurbished, but the cost is enormous to fix the ADA issues. If you look at the map next to the MBA, there is a Community Theater to replace the Marsee. The Marsee has 2,000 seats that is filled to capacity once a year and the other times is a not. We do rent it out for community events through the Civic Center.
