## **Open Meeting Introductions & Roll Call**

Jane Miyashiro called the meeting to order at 1:02 pm.

### Review/Approval of February 25, 2020 Meeting Notes

The committee reviewed the February 25, 2020 meeting minutes. A motion was made to accept the meeting meetings with a correction to a comment made by Teresa Palos during the discussion on the SISC informational open forums. Teresa said there was a lack of out-of-network benefits in the SISC plans and people were not happy with the lack out-of-network benefits.

### Premium & Claims Reports (Delta Dental & VSP)

Kim Gleeson reviewed the Dental Premium and Claims Report showing claims experience for the 12-month period February 2019 through January 2020. The expense loss ratio, which includes premium, claims, fees and expenses, shows a total expense loss ratio of 88.86%. It is down slightly from the same period the year prior which was at 89.55%.

Kim Gleeson reviewed the Vision Premium and Claims Reports. Using the same 12-month claims experience, February 2019 through January 2020, the Vision Plan paid loss ratio, less expenses, is running at 81.44%.

# Medical Marketing Update

Jane Miyashiro mentioned how El Camino College is in a new phase of operations because of the COVID-19 pandemic. The bulk of their employees are staying home and/or telecommuting. There is a lot of uncertainty now; people are concerned about staying home and keeping family members safe, which is a priority at this point. People are not in the state of mind to consider moving to a new health plan. This would cause disruption to many people and stability with the health plan is most important at this time.

Jane Miyashiro proposed that the committee suspend medical marketing research with no specific timeline when to start researching again. The Faculty and Classified members of the committee agreed with the proposal. Michele Whiting said the committee should consider looking at other pools besides SISC when they decide to start their research in the future. Majority of the committee was in support of this.

Valerie Jeffrey mentioned how employees are still struggling with the reason why the College is considering making a change. They are comfortable with their current doctors and having to change doctors during this pandemic would not put employees at ease.

Jane Miyashiro made a motion to suspend all medical marketing research and the motion was seconded by Polli Chambers-Salazar.
