Debbie asks for clarification about the student representation fee associated with the SSCCC. More money is going out than we are keeping. John from fiscal is unsure why that is, it may be that accounting books need to be updated. Senator Yeh is asking if too much money is budgeted towards external affairs trips. SDO Director Gonzalez and Advisor Debbie clarified that those rates are set by a per diem.
