Letter from Steel Metal Workers' Union:

Jo Ann noted that everyone on the committee received a letter from the Steel Metal Workers' Local Union 105. The settlement agreement with the Bookstore contractor on not paying prevailing wages to the subcontractor does not impact El Camino College, it is between the general contractor and the subcontractor. El Camino does pay prevailing wages. We cannot dictate to a general contractor who they can hire, we can only deal with general contractor. We are required by law to go with the lowest bid on any project, no choice. Just to let you know that on one of the bids the contractor is using approved subcontractors from the union list. Southland is one of the subcontractor that we have used for isolated issues, who is also on the list. Most of the subcontractors do attend these the mandated pre-bid meetings, which are open to anyone. I would encourage anyone with issues to speak with Bob Bradshaw and Randy Hartman.

Public Comment:

Richard Foss addressed the committee, letting them know that he was the one who sent the letters to the Citizens' Bond Oversight Committee, members of Board of Trustees, President, and Vice Presidents. He represents the Sheet Metal Workers' Union, Local 105. He wanted the committee to understand what happened with the Bookstore subcontractor caused great amount of grief and hardship for the families of the workers. He thanked Jo Ann for stating that El Camino does prevailing wages and that we do have a third party looking at labor compliance. He passed out newspaper articles to the committee for them to read at their leisure. He would like to opportunity to meet with the committee members to discuss this topic. Will Scott also addressed the committee on this top and said that he had worked with Mr. Bradshaw at Citrus on labor compliance.
