  - 1. Currently parking lot F has 200–400 parking spaces that have been blocked off due to pieces of concrete that have fallen off.   - 1. First is the Overview of ECC Budgeted State Revenues Unrestricted General Fund (UGF):
    - a. Line items 1 through 4 are self explanatory.
    - b. Line item 5 through 7 deals with the tax propositions passing or not.

    - a. The 9.9 million ties into line number 8 on the Overview of ECC Budgeted State.
