1) Approve Consent Agenda and Minutes:

NON-CONSENT AGENDA

I. PRESIDENT'S REPORT

Laurie McCarthy requested a moment of silence for Board of Trustees President Kenneth A. Brown.

- 1) Introduction of Guests Tamara Powers and Eman Dalili, potential new Board members
- 2) ECC Forensics Team
 - Members from the Forensics Team reported about their successful participation in the International Forensics Association's 33rd Annual Speech and Debate Tournament and Conference in Tokyo, Japan. They came in 5th in the competition and said it was great to have the opportunity to compete. They thanked the Board for their generous support.
- 3) Guest Speakers Allied Health Team
 - Dawn Charman, Director, Radiological Technology
 - o Graduating students since 1973.
 - o 100% pass rate on ARRT exam for 22 years.

- o 100% employment rate for 10 years.
- o 95% of the faculty are ECC graduates.
- Dr. Jeny Joy, Director, Nursing
 - o Goal is to prepare entry level nurses, to promote efforts to increase the pipeline of baccalaureate-prepared nursing.
 - o 84 nursing graduates in 2022.
 - o NCLEX pass rate of 93.51%.
 - o Total program costs are \$8,000.
 - Partnerships with Harbor UCLA, LACUSC, Providence Health Systems, Kaiser South Bay, and TMMC.
 - Foundation support includes testing support, clinical clearance support, and graduation pins.
- Dr. Russell Serr, Dean, Health Services & Athletics and Roy Mekaru, Director, Respiratory Care
 - Virtual Reality and Augmented Reality are allowing ECC to go in a new direction with their program.
 - o ECC awarded the opportunity to offer Baccalaureate Degree in Respiratory Care.
 - o ECC applied in January 2022 and was approved September 2022.
 - o Currently ECC is the only Respiratory Care BS degree offered in LA County.
- 4) Amendment to Articles of Incorporation for Warrior Pantry/LARFB
 - Amendment is as follows: "To provide assistance to underprivileged students in our
 college community as a method by which to advance education, provide basic food
 and to promote social welfare within the structure allowed by El Camino College."
 - Amendment will go to the Board of Trustees for approval and then will be filed with the State.

Esther Marcial made a motion to approve the amendment. Brooke Matson seconded. Motion passed.
