### I. PRESIDENT'S REPORT

Guests: Dr. Joanna Nachef & ECC Chorale Members

- 1) Presentation on fundraising request for a trip to Carnegie Hall May 25, 2024 Students from the Chorale introduced themselves with a song and then played a video clip of a performance.
  - The Need 30 students (20 Choir and 10 Orchestra) x \$1,699 = \$50,970 for Mid-America Productions Trip Package. Price includes 5 days 4 nights stay of \$1,699 per student (4-6 per room).
    - Airfare \$500 per student (not included in package or support request).
    - Next deposit is due in October, third deposit in December and final payment in March. They have already sent a \$20,000 deposit for 68 students.

- Hoping to take 90 El Camino Students (60% of class) and alumni; the request is for current ECC students unable to personally fund trip.
- Variety shows and other fundraisers are planned to raise additional funds.
- On May 18, 2024 they will perform a concert at ECC to showcase their Carnegie Hall performance.

Nina Bailey made a motion to fund up to \$51,000 for 30 students to attend the Carnegie Hall trip in May 2024. Kelsy Iino seconded. Discussion ensued. There was one opposition, and Ann O'Brien and Dr. Thames abstained. Motion passed.

- 2) Andrea Sala thanked Laurie McCarthy for her service as President and presented her with a gift to commemorate her two years as president of the Foundation.
- 3) Board members made self-introductions.

#### II. BOARD GOVERNANCE

1) A formal resignation from Victor Ibarra was read which will be effective immediately due to a change in his scope of work at SoCalGas.

#### III. FINANCIALS

Laurie McCarthy

- 1) June 30, 2023 Financials
  - Statement of Financial Position, Statement of Activities, and the Operating Budget were reviewed.
  - Total assets reflect the great work of Graystone Investment management. They are slated to present an overview at the September Board meeting.
  - Expenses under budget.

Laurie McCarthy made a motion to accept the June 2023 Financials as presented. Komal Ahmed seconded. Motion passed.

- 2) Presented Operating Budget Projections for 2023 2024
  - A raise was approved by ECC for Classified staff and Classified Administrators as well, which includes ECCF staff. The increase to payroll is only partially covered by the College and the Foundation must fund the remainder per our agreement with the ECCCD.
  - There is an increase in the Program Events line item which impacts additional line items such as printing, etc. due to holding more events this year.
  - The Foundation will increase the stewardship fee from 2% to 3% to help fund the budget increases.

  - Over 500 scholarships awarded to date for a total of almost \$750,000.
  - Additional scholarships still to be awarded in the fall.

- Behavioral and Social Sciences building, Arts Complex, and Student Wellness Center in Lot L all opening next month.

- The budget for a new Music Building must be re-scoped as the approved budget was \$50 million and the current needed to complete is \$100 million.

- A new retiree chapter has been created and will work with the Foundation to engage this important group.
- Wants to visit Rotary Clubs, Kiwanis, etc. to promote ECC.
