Prairie View A&M University: Sexual Assault Response Team



- State-wide Initiative to create/support Sexual Assault Response Team
- Requires all Texas counties to form an adult SART
 - Formalized coordinated response to a sexual assault that allows multidisciplinary professionals to coordinate and develop interagency responses to work together to address sexual assault by providing wrap-around support and communication
- Waller County SART

University of South Florida: Title IX Presidential Advisory Committee

 Meet monthly to discuss updates in TIX on the federal, local and institutional level. Provide feedback on campus needs as it pertains to Title IX/gender equity to the Title IX Office, which is reported to the VP of Institutional Equity and funnel to university president on a regular basis.

- Met with the President once a year to provide an annual report.
- Committee assisted with the annual Title IX Conference, addressing issues on campus such as lactation spaces, brainstorming supportive measures, campus safety, and promoting the campus climate survey.
