#### II. DISCUSSION/ACTION

A. Vehicle Safety Program Guidelines: (L. Barrera)

L. Barrera reviewed onscreen a draft of the Vehicle Safety Program Guidelines. A copy of the guidelines was included in the agenda packet.

B. <u>Veterans and Class Cancellations</u>: (P. Geary)

P. Geary consulted members regarding class cancellations and how to best notify veteran students in advance. Cancellations may affect the veteran's eligibility for benefits, or may result in money owed. VP Lopez invited P. Geary to attend the weekly deans' meeting in order to have further discussions on the subject.

C. AFT Update: (K. lino)

Contract negotiations continue. AFT members attended the 9/6 Board Meeting and will likely be conducting informational picketing on campus during college hour on Tuesdays. Campus Police is investigating multiple vandalisms targeting the Federation of Teachers office and its members.

D. <u>ECCE Update</u>: (R. Dietz)

Increase in complaints from staff regarding working out-of-class, which is defined as work outside your classification which exceeds 5 working days within a 30-calendar day period. R. Dietz will be following up with the divisions regarding the complaints.

E. <u>Facilities Update</u>: (R. Suppelsa)

F. <u>PBC Report:</u> (A. Grant)

8/31/23 meeting: R. Suppelsa introduced new members, provided a facilities update, and discussed the budget workshop. COLA received was 5.74%, which was less than the predicted COLA of 8.22%. State announced deficit factor of 2.29%. Fiscal cliff and hold harmless were also discussed.
