In addition, they will prepare the required Final Report and closeout documents

- 10.1 Adopt Resolution #05-17-2021A Resolution requesting Board of Supervisors of the County of Los Angeles to establish tax rate for bonds of the El Camino Community College District expected to be sold during fiscal year 2021-22, and authorizing necessary actions in connection therewith. The Resolution further authorizes the District officials to file a certified copy of the Resolution with the Board of Supervisors of the County and to deliver copies of the Resolution to the Auditor-Controller and Treasurer and Tax Collector of the County. Adoption of this Resolution is necessary to ensure that property taxes are levied during fiscal year 2021-22 for the payment of the Bonds. The Bonds are expected to be sold during Fiscal Year 2021-22 in the estimated amount of \$60 million.
- 11.1 Contract DLR Group Architect Services for the Demo of the existing Behavioral Social Science and Arts Buildings scope of services will include site analysis, drawings and specifications, DSA submittal, bid phase, and construction administration. The demolition of the existing Behavioral Science and Arts Buildings is in preparation for the construction of the new Music Building.
- 11.2 Amendment DLR Group Music Building Project This Amendment No.2 to the Agreement adjusts DLR's contract price from \$3,564,000 to \$4,946,882 to reflect a contract of 7.94897% of the updated \$62,233,000 construction cost It is recommended that the Board approve this Amendment No. 2 to the Agreement

Due to the expiration of the CMP, the Facilities Master Plan (FMP) needs to be updated for the next five (5) year term. A consultant will be need to prepare the FMP to cover the period 2022 to 2027.
- 10.7 Five-Year Construction Plan 2023-2037 As required by the Community College Construction Act of 1980, the El Camino Community College District is submitting its 2023- 2027 Five-Year Construction Plan and associated documents to the California Community Colleges Chancellor's Office. The Plan provides a list of proposed capital construction projects including those supported by Measure E.
- 11.1 Contract tBP Architecture Student Health/Wellness Center Project A space assessment of the existing Student Health Center was conducted for expansion purposes. Based on this assessment, there was limited space available to expand the Center to support needed Health and Wellness related programs for students. As a result, an alternative site was identified to build a new, larger Center.
