# Premium & Claims Reports (Delta Dental & VSP)

Kim Gleeson reviewed the Dental Premium and Claims Report showing claims experience for the 12-month period October 2020 through September 2021. The expense loss ratio, which includes premium, claims, fees, and expenses, shows a total expense loss ratio of 91.78%.

Kim Gleeson reviewed the Vision Premium and Claims Reports. Using the same 12-month claims experience, October 2020 through September 2021, the Vision Plan paid loss ratio, less expenses, is running at 84.35%.

**Open Enrollment Update: BenefitBridge Statistics** – Valerie Jeffrey reviewed the BenefitBridge statistics.

- BenefitBridge received a total of 132 calls during open enrollment.
- BenefitBridge received a total of 12 emails during open enrollment
- The summary of total calls and emails received by BenefitBridge Support represents 21.17% of those who used BenefitBridge to enroll in benefits.

Enrollment Counts for 2021 vs 2022 - Jamie Kaplan reviewed the 2021 and 2022 enrollment counts for the CalPERS medical plans and the ancillary coverages. The report also showed the counts for the current PPO plans that would be transitioning to the PERS Platinum and PERS Gold plans. Overall, there was not a lot of movement in plans from 2021 to 2022.
