M. Chaban called the meeting to order at 1:10 p.m.

CCC Update

There were no Business Division proposals reviewed at the last CCC meeting. There was discussion regarding permissions in Curriculog; that is, who has access at what levels. This is an ongoing conversation in CCC – no determination was made. It was announced that Dr. Jean Shankweiler is retiring, and Dr. Jacqueline Sims will step in as the Interim VP of Academic Affairs. CCC Chair Janet Young will be retiring in 2022, and Edwin Ambrosio will serve as Chair-Elect for a year, then take over as CCC Chair in fall 2022.

Course Review

D. Pahl presented his revised proposal for Business 40. Due to the current course renumbering action, Business 40 will be changed to Business 106. During review, some minor revisions were suggested. D. Pahl will incorporate these revisions in Curriculog and continue with the approval process. Once updated, an email vote by the DCC will be conducted, and DCC members will approve in Curriculog.

Proposals for Business 164, 165A, 165B, 165C and 165D will be tabled until fall 2021, pending further department review. Due to this current situation, proposals for the Accounting AS Degree and Certificate of Achievement, as well as the CTEC Certificate, are also be tabled until fall 2021.
