## MINUTES

### I. INFORMATION/ANNOUNCEMENTS

#### A. Minutes from October 6, 2016

- Approved.

#### B. Spring 2017 Reviews and Schedule

- The Spring 2017 schedule was reviewed and discussed.
- The courses in italics are the ones we want to get done first (THEA 185 & THEA 197abcd).
- W. Georges informed W. Cox that THEA 185 & THEA 197abcd are not part of the CTE. W. Cox will talk to Q. Chapman about these courses.
- Courses that were held over from Fall 2016 were reviewed.
- Courses at level 5.5 are at the originator level and need to have the originator go in and indicate that changes have been made so they can go to level 6 for Q. Chapman to review. Film 120 & 122 are also at level 5.5.
- L. Adamis questioned Dance 164 (consider revision). W. Cox spoke with D. Berney re: this course being hard to fill. D. Berney suggested having 2 8-week courses instead of one 16-week course. L. Adamis will work with W. Cox on this.
- The Dance AA needs to be revised.

- The Art Gallery Certificate needs to be CTE. J. Dallal informed W. Cox that they were told it cannot be CTE because there is no Top Code for it. W. Cox will follow up with Q. Chapman on this.
- P. Chambers inquired about the issue with the Music AA-T due to Music 101 being unable to get through as a G.E. W. Cox will look into how to fix the problem.
- W. Cox reviewed the Spring 2017 Curriculum Review Schedule deadlines for Rounds 1 & 2.

## II. DISCUSSION/ACTIONS

### A. High School/Dual Enrollment

W. Cox informed the committee that we are doing MOU's with TUSD and have a lot of contracts with high schools.

- Davinci School
  - Davinci School has modeled their curriculum on ECC and are requesting COMS 100, Art History and 2-D Design courses.
  - They want their instructors to teach these courses at their school.
- Service Area Districts
  - City Honors, Centinela Valley
  - We have had a request for an articulation agreement from Gardena High school, which is not in our district.
  - There are some concerns with courses taught at the high school

### B. Online Courses

- ECC is interested in offering an online AA.
- J. Shankweiler inquired about what G.E. courses could be offered online. W. Cox suggested hybrid courses for COMS.

### C. New Proposals

- J. Minei suggested creating a Fine Arts Business courses for the performing arts majors that would touch on taxes and other aspects of performing arts business practices.
