III. OTHER

- o L. Alamillo and A. Ahmadpour presented a proposal for a new catalog course description for Art 101 (Art & Visual Culture in Modern Life).
- o The DCC voted and agreed to send proposed changes to Art 101 to CCC.
- W. Brownlee reviewed and explained proposed changes to Art 195 and new course proposal for Art 295 – Portfolio Development and explained the reasoning for the Enrollment Limitation for this course.
- o Art 295 would be a combined course with intermediate level courses such as Art 142.
- o J. Dallal raised concerns about requesting 10 Artworks as a condition of enrollment and concerns with the similarity with Independent Study courses.
- o The proposal for Art 295 still needs to be approved by the Art department.
- o W. Brownlee reported the proposal has already been submitted for review. It is currently at 2.0 and after the prescreening it will move to 3.0. D.L. Hayden will check with Q. Chapman about how to move it to 3.0.
- o The DCC will look at Art 295 on 10/24.
